#### ADDENDUM NO. 6

This addendum issued October 6, 2017 becomes in its entirety a part of the Invitation for Bid IFB #2017-21 E-P-H as is fully set forth herein:

- Item 1: Q: On H107 Addendum 2 drawing, There is an exhaust fan above EF-15 taged with a ? mark that is to be replaced. Please clarify what fan model is to be installed in this location.
  - A: 700 cfm, 0.5 SP, 1/3 Hp, 115/1/60 volt, Greenheck GB-091
- Item 2: Q: On H102 Addendum 2 drawing, the exhaust fan schedule show EF9, EF11, and Ef12 but these tags are not shown on the roof top mechanical plan. Does these fans get replaced, and if so where?
  - A: Do not replace.
- Item 3: Q: The through the wall air cooled condensing unit schedule does not appear to correspond with the drawings. AC-3 is for a three bedroom unit; I cannot find three bedroom units on the plans. Also the large one bedroom units show an air conditioner in the bedroom, but there is not a bedroom option on the drawings. This is also the case for the UFAS 2 bedroom unit that goes in one of the bedrooms. Please clarify.
- A: Do not bid AC-3 for units. For large one bedroom unit provide same AC in bedroom as living room. Do the same for the UFAS two bedroom units.
- Item 4: Q: Do the range hoods located in UFAS units require remote control switches or are the existing able to be reused?
  - A: Range hoods require new remote switches in UFAS units.
- Item 5: Q: In Building type G the furnaces are tagged as an F4, however the AC is tagged AC3. Is this correct?
  - A: FUR-4 is not being used. Use FUR-3 in Bldg G.

Item 6: Q: In building type L and M are the existing exhaust fans remaining in place?

A: Reference Notes: Exhaust Fan: Remove existing toilet exhaust fan and replace with new ceiling mounted exhaust fan. De-energize electrical circuit prior to demolition. (Typ. All low rise units). Refer to H-121 and H-122.

Item 7: Q: Specification section 230900 states "Upgrade the existing building automation system to a complete, fully communicating (via BACnet communication protocol only), DDC system as shown on the contract drawings, except A & B, as indicated." I do not see any mention of DDC upgrades on the contract drawings; the HVAC equipment appears to be stand alone. Please clarify what equipment is to be included with the DDC controls and where this information is located on the drawings.

A: Do not upgrade existing BAS. This is not part of this project.

Item 8: Q: Per specification 230593, please clarify what equipment requires balancing. Are we to balance the equipment or the grilles as well?

A: Balance equipment installed. Grilles remain at existing air balance.

Item 9: The Proposal due date, time and location remain unchanged at October 12, 2017 at 2:00 p.m., at HACP Procurement Dept., 100 Ross St. 2<sup>nd</sup> Floor, Suite 200, Pittsburgh, PA 15219.
