## **Scope of Work**

Two areas for asphalt work:

### **Basketball Court:**

- Key edges to eliminate hump and to create a smooth transition after topping has been installed
- Key to be 1-½" deep by 18" wide around patches
- Areas: 10 X 54, 20 X 18, 40 X 34 and 4 X 4 – approximately 254 square yards
- Clean area
- Apply tack to create a bond to existing asphalt and to topping
- Furnish and install 1-3/4" of 9.5MM wearing asphalt, then roll to compaction
- Seal edges using hot tar
- Fill cracks (big ones only) using hot tar
- Seal coat lot, single coat of sealer

### **Main Lot:**

- Key edges at all concrete walkways
- Key to be 1-½" deep by 18" wide around patches
- Areas: 9 X 18, 34 X 38, 34 X 34, 9 X 19, 9 X 19 AND 34 X 34 – approximately 475 square yards
- Clean area
- Apply tack to create a bond to existing asphalt and to topping
- Furnish and install 1 3/4" of 9.5MM wearing asphalt, then roll to compaction
- Seal edges using hot tar
- Fill cracks (big ones only) using hot tar
