ADDENDUM NO.1

This addendum issued October 25, 2012 becomes in its entirety a part of the Request for Proposal RFP#450-27-12 Rebid as is fully set forth herein:

- Item 1: Q: We understand that there was a firm performing these services prior to this solicitation being released and that the contract is being recompeted early without all options being exercised. Who is the incumbent and what is the reason for the early recompete of the contract?
 - A: On line Rental Exchange is the current vendor.
- **Item 2:** Q: As part of the Minority and Woman Business Participation Plan, must the minimum utilization thresholds indicated be met monthly, quarterly or annually?
- A: The goals are throughout the entire contract. Quarterly letters are sent to the M/WBE participants requesting pay and usage information.
- Item 3: Q: Can you confirm that you are looking for a single price under "State Search" that is only for a single Pennsylvania Statewide Criminal Search (to include the current \$10 state fee)?
 - A: Yes, a single price, which should include all applicable fees.
- Item 4: Q: Due to mailing timelines and the letters/MBE/Section 3 areas that need to be completed, would the authority consider a slight extension to ensure all necessary documentation can be completed in time?
 - A: Please refer to Item 11.

Item 5: Q: For out of state searches, would it be acceptable to include an additional price sheet giving the authority other search options to include statewide searches outside of Pennsylvania?

A: Please refer to revised fee sheet, which is included as Attachment B to this addendum.

Item 6: Q: As the authority has stated that it would be allowing state costs to be passed through (excluding Pennsylvania), we have often used a single rate for statewide searches plus pass thru fees necessary to access the information without additional markup to the state fee. We then would attach a list of current pass through fees for the client. Would this be acceptable?

A: Please refer to revised fee sheet, which is included as Attachment B to this addendum.

Item 7: Q: Housing authorities are entitled to receive FBI fingerprint checks on their tenants. FBI Channelers are able to provide this service, giving the authority a full FBI rapsheet in a matter of minutes. Would this be something the authority would be interested in receiving additional information?

A: No.

Item 8: Q: County searches occasionally entail a pass through fee as well. Would it be acceptable to pass those fees on to the authority as well without additional markup to the fee for counties outside of Pennsylvania if necessary?

A: Please refer to revised fee sheet, which is included as Attachment B to this addendum.

Item 9: Q: Can you confirm that on the pricing page, all prices are by item and as requested by the authority?

A: Yes


