#### ADDENDUM NO.1

This addendum issued March 24, 2015 becomes in its entirety a part of the Request for Proposals RFP#400-13-15 as is fully set forth herein:

**Item 1:** Q: Does HACP staff currently perform the HQS and UPCS inspections? If not, who is currently performing these inspections?

A: No, LIPH team does not complete UPCS inspections - McCright inspects LIPH units. HACP staff currently performs HQS Inspections.

Item 2: Q: Is the existing staff performing HQS and UPCS inspections unionized?

A: The HACP staff currently performing HQS inspections is unionized.

Item 3: Q: Can all inspection documents be submitted electronically?

A: Vendor is responsible for sending notices to residents via mail. Copies of notices can be forwarded electronically to HACP. Work orders are created by the inspector, this is an electronic process. Summary documents are also electronic.

**Item 4:** Q: Does the current vendor have electronic data transfer between Emphasys Elite and their software?

A: Current vendor has access to Elite for UPCS. For HQS inspections, no.

Item 5: Q: Scope of Services G-15: Develop and implement a quality control program that exceeds the minimum standards required under 24 CFR 985.2, 24 CFR 985.3 (e) and (f) for all inspections conducted on a monthly basis. Does HACP need copies of all performed Vendor - QC inspections?

A: In the instances where QC inspections are completed on LIPH units, HACP would want copies of the reports. For HQS inspections, yes.
