- Item 2: Q: Based upon previous history,
 - a. How many delivery locations are there?

 - A: On an as needed basis.
- c. How much / what is the case count of liners, gloves and boots ordered at a time?

- Item 3: Q: Would you please provide the previous award tab with winning vendor(s) and item(s) or the current pricing specifically for the liners, gloves and boots listed in the bid?
- A: You must file a Right to Know Request. The Right to Know Request contact and form can be found on our website (www.HACP.org) on the contact tab under Open Records Officer.
- Item 4: Q: Are substitutions / equivalents permitted? Including / limited to the rubber boots listed as Rainfair? 000-001 000-005?
- A: HACP will accept items that are equivalent to the items listed in the Catalog. When submitting alternatives please insert a separate page referencing HACP's Item number with the same information columns from *Attachment 1 Just-In-Time Catalog*
- Item 5: Q: Based upon previous history, has this bid been awarded to one vendor or multiple vendors?
 - A: Multiple.
- Item 6: Q: Can you tell me if the cabinets on this just in time bid have to be HUD approved cabinets or are we just bidding standard cabinets as listed in the bid?
- A: Yes. The cabinets must meet HUD Minimum Property Standards for Housing and ANSI/KCMA A161.1 Recommended Performance and Construction Standards for Kitchen and Vanity Cabinets.
- Item 7: The proposal due date, time and location remain unchanged at March 13, 2018 at 11:00 AM, at the HACP Procurement Dept., 100 Ross St. 2nd Floor, Suite 200, Pittsburgh, PA 15219.
