**Item 1:** The scope of work pages 33 and 40, Application section, part I is hereby deleted and replaced with the following:


**Three Coats of paint are to be applied

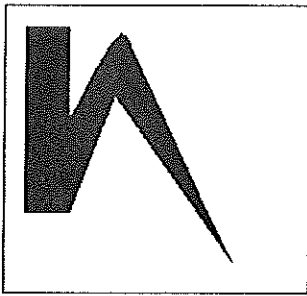
