SECTION I INTRODUCTION

The HACP is a municipal corporation, formed under the U.S. Housing Act of 1937, codified at 42 U.S.C. Section 1401 et seq. as amended and the Housing Authority Law of Commonwealth of Pennsylvania codified at 35 P.C. 1542, et. seq. as amended. As such, the HACP is charged with providing “affordable decent, safe and sanitary housing for low-income persons.”

The HACP has approximately 350 employees and services over 10,000 residents. The Authority itself maintains approximately 5208 units of rental housing; and, through its Section 8 program, funds the rental of more than approximately 5247 other units of privately owned housing.

Major operational departments include Property Management, Maintenance, Occupancy, Section 8, and Modernization & Development. Major administrative departments include Legal, Finance, Management Information Systems, and Human Resources. Our public and community relations departments are Community Affairs and Resident Self-Sufficiency. All departments work together to achieve the goals of the Authority that are set by the Board of Commissioners. Day to day decision-making rests with the Executive Director, who reports to the Board of Commissioners on a regular basis.

The Authority is contemplating the award of a professional service contract or contracts for a period of three(3) years with two(2) one(1) year extension options, in the form of the Sample Contract (**Attachment A**) through this solicitation process.

SECTION II SCOPE OF SERVICES

1. PROJECT INTENT

The intent of this RFQ is for hardware, software, installation, maintenance and technical services in connection with HACP's existing Security Camera System installed across 16 sites. Bidder will be responsible for quarterly and annual maintenance, providing support for the camera system in the event of an outage, and any requested moves, adds, and changes (MACs). Bidder to provide response times as defined in this RFQ. All monthly and annual maintenance, and requested spare parts to be on standby shall be included in the Bidders quote. The quote shall be for 3 years of coverage with two 1 year optional extensions.

2. GENERAL INFORMATION

HACP's Security Camera System includes 813 Samsung IP Camera's deployed across the following 16 sites:

1. Allegheny Dwellings
2. Arlington Heights
3. Bedford Dwellings
4. Caliguiri Plaza
5. Carrick Regency
6. Finello Pavilion
7. Glen Hazel
8. Gualtieri Manor
9. Homewood North
10. Mazza Pavilion
11. Morse Gardens
12. Murray Towers
13. Northview Heights
14. PA-Bidwell
15. Pressley Street
16. 200 Ross Street

See Attachment A to the scope of work for equipment and quantities installed at each site. The camera security system consists of Samsung cameras, Intransa servers and workstations, Alcatel-Lucent Switches, GarrettCom Switches, IFS Media Converters, Altronix equipment, APC UPSs, Motorola Canopy wireless, video monitors, and Milestone XProtect camera management software.

Some equipment is still under warranty through the manufacturer or the original installer. See Attachment B to the scope of work for a list of all equipment and the warranty expiration dates.

HACPs sites have 1Gbps dedicated fiber circuits managed and maintained by Salsgiver, Inc. The 1Gbps circuits are aggregated into a 10Gbps fiber circuit to HACP headquarter's located at 200 Ross Street.

3. SCOPE OF SERVICES

3.1. The Bidder shall provide 24x7x365 support as needed for minor, major, and critical outages. The Bidder shall provide a not-to-exceed troubleshooting cost for each reported outage. The troubleshooting cost shall include all actions taken by the Bidder up to the time of determining the cause of the outage. The cost to repair the equipment shall be billed using the time and material method using unit prices for labor and equipment included in this bid.

3.2. The Bidder shall provide the following maintenance on a quarterly (every 3 months) basis:

3.2.1. Server & workstation software updates – Bidder shall install updates to servers and workstations on a quarterly basis. Bidder shall backup all server images after software updates are applied.

3.2.2. Software and firmware upgrades – Bidder shall check for available upgrades for the cameras, switches, servers, and workstations. Upgrades to the servers and workstations include the Microsoft OS, Microsoft Desktop, Milestone, & VMWare. Once upgrades are identified the Bidder shall provide HACP with a quote for upgrade costs.

3.2.3. Server preventative maintenance – Bidder shall inspect each server for free disk space, error logs, and utilization. Bidder shall physically inspect server for dirt accumulation, fan function, and all other potential environmental issues. Bidder shall provide a quarterly report detailing the findings from these inspections.

3.2.4. Camera view reviews – Bidder shall check each camera view for any viewing issues such as:

- Outages
- Out of focus cameras
- Out of position cameras

Bidder shall provide all findings to HACP in a report due no more than 2 weeks after completion of the review.

3.3. The Bidder shall provide the following maintenance and services on a semi-annual basis:

3.3.1. Dome cleaning – Twice a year for outdoor camera's. Dome cleaning shall include wiping the dome internally and externally with a Samsung approved cleaning solution. Bidder shall also clean the interior of the camera (bugs, dirt, debris, etc.).

3.4. The Bidder shall provide the following maintenance and services on an annual basis:

- 3.4.1. Dome cleaning – Once a year for indoor camera's. Dome cleaning shall include wiping the dome internally and externally with a Samsung approved cleaning solution. Bidder shall also clean the interior of the camera (bugs, dirt, debris, etc.).
 - 3.4.2. Tree trimming review – During the month of June the Bidder shall review all outdoor camera views and wireless line of sight for trees and branches that have grown and interfere or may soon interfere with camera views and line of sight between wireless equipment. Once the Bidder identifies trees to be trimmed, the Bidder shall mark each tree and provide HACP with a detailed list and scope of work for each tree (remove, trim, etc.). HACP will coordinate and be responsible for paying a local contractor to perform the work.
 - 3.4.3. Camera system training – Bidder shall provide 16 hours of training per year as requested by HACP to train basic and admin users as needed.
 - 3.4.4. Annual technology review – Bidder will meet with HACP and discuss the current status of HACP equipment and technology options available to HACP.
- 3.5. The Bidder shall store & maintain the following files and information:
- 3.5.1. Switch Images and configuration files – The current configuration files will be made available to the winning Bidder.
 - 3.5.2. Server Images – Bidder shall backup critical server data (not camera system recordings) and store at an off-site location.
 - 3.5.3. Licenses – Bidder shall maintain all licensing information for all applicable products installed such as but not limited to Microsoft Server, VMWare, Milestone, and Samsung Cameras.
 - 3.5.4. Upgrade Status – Bidder shall maintain a spreadsheet with current software/firmware revisions on installed camera system equipment. This document shall be updated after each upgrade and presented to HACP upon request.
 - 3.5.5. As-Built Documentation – Bidder shall keep all as-built documentation up to date and accurate. This information shall be made available to HACP each time it is updated and upon request. The existing as-built documentation shall be made available to the winning Bidder. Existing as-built documentation is in AutoCAD and Microsoft Excel formats.
- 3.6. Provide optional pricing for warranty coverage through the manufacturer:
Bidder shall provide optional pricing for extended warranty coverage on installed camera system equipment for 3 years. Warranty terms and conditions shall be supplied with warranty pricing. The pricing for extended warranty coverage is optional and to be included as such as part of this bid.
- 3.7. Provide optional pricing for software assurance through the manufacturer:

Bidder shall provide optional pricing for software assurance (annual fee for software upgrades) for eligible camera system software. The camera system uses the following software:

- Milestone XProtect Corporate 4.1A
- Milestone XProtect SmartWall 1.0B
- Milestone SmartClient 7.0C
- VMWare Player 3.1.1
- Microsoft Server 2008 Standard.

3.8. Support Personnel Certifications

The Bidder shall provide and update as necessary the list of manufacturer certified repair personnel. Certified personnel shall be defined as those repair personnel who have attended the manufacturer's training classes on the type and model equipment installed at the HACP's locations, who have the proper experience and licenses for the work to be performed, and who are recognized by the manufacturer as "qualified" technical support personnel. Only certified repair personnel as described above shall be considered as adequate for response to a failure. Here is a list of manufacturers (hardware and software) that the Bidder and/or sub-contractors used by the Bidder must be certified in:

- 3.8.1. Samsung IP camera's
- 3.8.2. Intransa Servers
- 3.8.3. Milestone XProtect Corporate
- 3.8.4. Alcatel-Lucent Switches
- 3.8.5. Leviton/Superior Essex cabling system (fiber and copper infrastructure)
- 3.8.6. APC UPS's.
- 3.8.7. Microsoft Server 2008 Standard
- 3.8.8. Microsoft Desktop
- 3.8.9. VMWare

3.9. Bidder shall purchase and store a minimum amount of spare parts defined in Attachment C. This equipment shall be used to replace a device upon failure to minimize downtime. If the original product is still under warranty, the Bidder will be required to contact the manufacturer for repair or replacement of the defective device. If a product is no longer covered under warranty and is not repairable, the Bidder shall properly dispose of the equipment and order additional equipment to replenish the stock of stored hardware. All equipment removed from the HACP sites (whether for defective or replaced equipment) shall have the model and serial numbers of the equipment recorded and sent to HACP for inventory control. If the equipment originally stored is no longer available the Bidder shall provide HACP with a quote to replace the hardware with equipment that meets or exceeds the specifications of the original equipment. HACP shall be billed in accordance with the Bidders attached Bill of Materials to replenish the minimum amount of stored hardware required in (Attachment C to the scope of work). Upon completion or termination of the maintenance contract, all stored equipment shall be delivered to HACP.

4. MAJOR & MINOR OUTAGES

4.1. Minor Outage

A minor outage shall be defined as an incident in which 1 - 3 cameras are no longer viewable or recording at any one site.

4.2. Major Outage

A major outage shall be defined as an incident in which 4 or more cameras are no longer viewable or recording at any one site. This includes switch outages as well as backbone cabling damage.

4.3. Critical Outage

A critical outage shall be defined as an incident in which all cameras are no longer viewable or recording at any one site. This includes server or primary switch outages and backbone cabling damage.

5. RESPONSE TIMES & TIMES TO RESOLVE

Once HACP detects an outage and determines if the outage is classified as a minor, major or critical outage, HACP will contact the Bidder. The Bidder must provide HACP with a toll-free number available 24x7x365. The bidder must adhere to the following requirements:

5.1. Minor Outage

The Bidder shall respond within 8 business hours of a reported minor outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 12 business hours unless the cause of the outage is due to cabling damage.

5.2. Major Outage

The Bidder shall respond within 5 hours (business and non-business) of a reported major outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 12 business hours unless the outage is due to cabling damage.

5.3. Critical Outage

The Bidder shall respond within 3 hours (business and non-business) of a reported critical outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 8 business hours unless the outage is due to cabling damage.

6. PENALTIES

Should the Bidder fail to meet the required response times & times to resolve in this bid the following penalties may be assessed against the Bidder:

- If the Bidder fails to meet the response times response times & times to resolve for a minor, major, or critical outage more than one time in a period of 30 days HACP reserves the right to terminate the maintenance contract with the Bidder.
- If the Bidder fails to meet the response times response times & times to resolve for a minor, major or critical outage the following penalties may be assessed against the Bidder by HACP:
 - 1 – 2 Hours late = \$100 an hour.
 - 3 – 4 Hours late = \$200 + \$200 an hour.
 - > 4 Hours late = \$600 + \$400 an hour.

7. SERVICE CENTER

Bidder shall list the address of the service center that will install and maintain the system and state its boundaries.

8. CABLING DAMAGE

In the event cabling is damaged, the Bidder shall provide a quote to HACP (within 12 business hours of determining the outage is related to damaged cabling) to repair the cabling. All cabling work shall be completed by individuals certified in Leviton/Superior Essex cabling systems. The Bidders quote to repair the cabling must include time to resolve upon acceptance of the quote by HACP. HACP reserves the right to reject any quote and obtain quotes from other contractors certified in Leviton/Superior Essex.

9. MOVES, ADDS AND CHANGES

9.1. Moves, Adds and Changes Requests

Requests for moves, adds and changes shall only be accepted when presented in writing (paper or electronic) from authorized representatives of HACP. HACP will provide the winning Bidder with a list of authorized representatives. Technicians performing moves, adds and changes activity shall respond on-site to complete the work within one week of requested MAC's.

9.2. Moves, Adds and Changes Pricing

The Bidder shall provide as part of the response to this bid, a detailed listing of various moves, adds and changes activities and their approximate costs to be expected if HACP requests work. List of common MAC's associated with the camera system:

- Adding or removing camera's
- Changing a camera view
- Adding or removing camera system users
- Adding switches to support additional camera's
- Installing Milestone software on PC's
- Adding additional wireless equipment
- Connect additional HACP provided equipment to the communications infrastructure.

9.3. Inventory

If any moves, adds and changes activity HACP elects to undertake requires specialized inventory of parts, supplies, or test equipment, the Bidder shall make all such inventory available to HACP at a reasonable cost.

10. IN SCOPE – FIXED PRICING

These services and equipment must be included in the maintenance contract cost:

- 24x7x365 support for troubleshooting outages.
- All quarterly, semi-annual and annual maintenance & services as identified in Section 4.
- Initial cost to purchase all equipment listed in (Attachment C to the scope of work) for spare camera system parts.
- Maintain switch images and configuration files, server images, and as-built documentation.

11. OUT OF SCOPE – TIME & MATERIAL

These services are to be provided on a time and material basis throughout the duration of the maintenance contract:

- 24x7x365 support for repair, MAC's, and administrative assistance with the security camera system.
- Work not covered under manufacturer's warranty on covered equipment.
- Cost to purchase equipment as needed to replenish spare camera system parts.

Out of scope services provided on a time and material basis throughout the duration of the maintenance contract shall be provided on a cost + basis. Cost shall include labor, materials, and markup/overhead. All potential labor and material costs shall be included in the unit cost sheet (Attachment D to the scope of work). The Bidder shall include the markup/overhead percentage in the unit cost sheet.

The Professional Services Contract that is anticipated for use to obtain these services is included herein as **Attachment A to the RFP - Contract.**

SECTION III GENERAL REQUIREMENTS

An Offeror may be an individual or a business corporation, partnership, firm, joint venture or other legal entity duly organized and authorized to do business in the City of Pittsburgh, financially sound and able to provide the services being procured by HACP.

If an Offeror has been debarred, suspended or otherwise lawfully precluded from participating in any public procurement activity, such firm shall disclose that information in its offer, which may be sufficient ground for disqualification. If the selected firm fails to disclose such information and HACP discovers it thereafter, then HACP could terminate the contract.

Each Offeror must be in good standing with HACP, and any Federal, State or Municipality that has or has had a contracting relationship with the firm. Therefore, if a Federal, State or Municipal entity has terminated any contract with an Offeror for deficiencies or defaults, that Offeror is not eligible to submit a Response to this Solicitation.

If Offeror is not in good standing with HACP, and/or any Federal, State or Municipality this must be disclosed.

Offeror must have and maintain all necessary insurance to cover malpractice liability and workers' compensation and submit proof of it with their proposal submission.

SECTION IV CONTENT OF RESPONSE DOCUMENTS

Offerors submitting Proposals should fully read and comprehend the *Instructions to Offerors Non-Construction* provided in **Attachment B** and *General Conditions – Non Construction* provided in **Attachment C**. Proposals received without all of the required information may be deemed non-responsive. Offerors must submit one original plus three (3) paper copies of their technical proposal and one (1) electronic copy in .PDF format on a CD, and one (1) original paper, one (1) paper copy and (1) electronic copy in .PDF format of the fee proposal in a **separate sealed envelope**. Proposals must include, in the same order as below and using the forms attached hereto, the following information, exhibits and schedules:

A. General Information

1. Letter of Interest (Cover letter)
2. Type of Organization; Corporation, Partnership, Joint Venture or Sole Proprietorship. Names of shareholders, partners, principals and any other persons exercising control over the Firm.
3. Description of the Offeror's capacity including staff resources
4. Organizational Certifications:
 - (a) Copies of Certificate of Incorporation, Partnership Agreement, Joint Venture or other organizational document.
 - (b) A corporate resolution signed by the Secretary of the Corporation and notarized, certifying the name of the individual(s) authorized to sign the offer, the contract and any amendments thereto.

B. Previous Related Experience

1. The bidder shall list three (3) firms, governmental units, or persons for whom the bidder has previously performed work of the nature requested under this RFP. Name of the contracting entity.
2. Name, title and a telephone number of a contract person for each identified contracting entity to permit reference checks to be performed. The identified party must be one who has first-hand knowledge regarding the operation of the contracted facility or project and who was involved in managing the contract between the Offeror and the contracting entity.
3. In addition to the references, all bidders will provide the last three jobs they performed, contact information from the job and all change orders related to the job and the reason for each.
4. All bidders will provide information on the most recent HACP job to include all change order information and the reason for each. The most recent HACP job can be one of the 3 last jobs performed if that is the case.

C. Proposed Staffing and Sub-consultants Responsibilities and Qualifications

Provide the following information relative to the proposed staffing and sub-consultants for this contact:

1. Provide background information regarding each identified Staff member that accurately describes his or her employment history and relevant experience providing services similar to those described in this Request for Qualifications.

Demonstrated commitment to assist the HACP in meeting its requirements and goals related to Section 3.

Deductions
Points may be deducted for failure to submit all required documents or for submitting irrelevant or redundant material.

Although not mandatory, all prospective respondents are strongly encouraged to attend the Pre-Submission Conference. Failure to attend will not excuse the legal contractual duty imposed by this Solicitation and the subsequent contract on each respondent to familiarize itself with the Request for Qualifications.

D. Evaluation and Award Process

HACP staff will review each Proposal to determine if it was complete and if it was responsive to this Request for Qualifications. HACP may allow an Offeror to correct minor deficiencies in its Proposal that do not materially affect the Proposal.

All Proposals determined to be complete and responsive will be provided to an HACP Evaluation Committee. HACP's Evaluation Committee will evaluate the Proposals utilizing the criteria established in Section V of this Request for Qualifications.

HACP reserves the right to interview Offerors in the competitive range, request additional information from selected Offerors and/or negotiate terms and conditions with selected Offerors.

HACP will perform a responsibility determination of the highest ranked Offeror which may include reference and financial background checks.

HACP will award a contract to the highest-ranked Offeror or Offerors determined to be responsive and responsible and whose offer is in the best interest of HACP.

HACP shall not be responsible for and will not reimburse any Offeror for any cost(s) associated with preparing a proposal.

A Proposal submitted by an Offeror does not constitute a contract, nor does it confer any rights on the Offeror to the award of a contract. A letter or other notice of Award or of the intent to Award shall not constitute a contract. A contract is not created until all required signatures are affixed to the contract.

Prior to contract execution of any professional service contracts which have a potential amount of \$25,000.00 or greater, the selected firm may be required to appear before and present a Minority and Woman Owned Business participation plan to the City of Pittsburgh Equal Employment Opportunity Review Commission for approval. Any HACP contract which has a potential amount of \$50,000.00 or more is subject to approval by the HACP Board of Directors.

**PROFESSIONAL SERVICE CONTRACT
FOR
Security Guards for the Family Communities**

This Agreement is made as of _____ between HOUSING AUTHORITY OF THE CITY OF PITTSBURGH, a body corporate and politic created under the provisions of the Housing Authorities Law, as amended, having its principal office at 200 Ross Street, Pittsburgh, Pennsylvania 15219 ("Authority"), and _____, having its principal office at _____ ("Contractor").

PREAMBLE

Authority desires the Contractor to provide Security guards for the family communities
Contractor desires to provide to the Authority Security guards for the family communities.

AGREEMENT

In consideration of the mutual covenants and promises set forth herein, the parties hereto, intending to be legally bound hereby, agree as follows:

1. Engagement. Authority hereby engages Contractor to render the following services set forth on Exhibit A (the "Services").

Contractor hereby accepts such engagement and covenants that Contractor will devote and will cause its employees to devote their best efforts, knowledge and skill to the performance of the Services and such additional services as may be mutually agreed upon by Authority and Contractor.

It is understood that the Contractor's Services shall be rendered at such times and places as directed by Authority.

Authority may at any time make changes to the Services to be performed. If any such change causes an increase or decrease in the rates or the time required for performance of the Services, Authority shall make an equitable adjustment in the rates and the time required for performance of the Services, and shall modify this Agreement accordingly.

2. Contractor Conflicts. Contractor agrees that neither Contractor nor its employees shall, directly or indirectly, engage in any activity, which would detract from Contractor's ability or its employees' ability to apply their best efforts, knowledge and skill to the performance of the Services. Contractor is charged with the responsibility to promptly disclose to Authority any situations that may create possible conflicts of interest so that appropriate action can be taken to address such situations. No member, official, or employee of Authority, during

his or her tenure or for one year thereafter, shall have any ~~interest~~ interest in this Agreement or the proceeds thereof.

Contractor may not participate in the award or administration of a contract supported by Federal funds if a conflict of interest, real or apparent, would be involved.

In the event Contractor is or becomes aware of a conflict of interest and fails to disclose the conflict to Authority; the Authority may immediately terminate this Agreement pursuant to paragraph 7(ii)(b) hereof.

3. Compensation. In full compensation for the Services to be rendered by Contractor to Authority hereunder, Authority agrees to pay Contractor for the Services in accord with the Fee Schedule set forth on **Exhibit B**; however, the compensation of costs for services not to exceed fee of \$_____. No work or expenses for which an additional cost or fee will be charged by Contractor shall be furnished without the prior written consent of Authority.

Contractor shall submit monthly invoices to Authority, which invoices shall include an itemization of the hours expended by Contractor and Contractor's employees and the nature of the Services performed and shall be prepared in a form reasonably satisfactory to Authority.

Contractor shall use its reasonable business efforts to submit invoices within 45 days of rendering Services.

Authority shall use its reasonable business efforts to process and pay each such invoice within 30 days of its receipt.

4. Term. The commencement date for performing the Services shall be the date of this Agreement, listed above, and will continue for an initial term of three (3) years with two (2) one (1) year extension options at the discretion of the Authority, unless sooner terminated as provided herein.

5. Contractor's Obligations. Contractor shall comply with the following:

(a) If requested, Contractor will submit monthly written narrative progress reports to the Authority. Contractor shall retain all records in connection with this Agreement or the Services provided herein for a period of three years after all payments required herein are made and all other pending matters are closed.

(b) This Agreement is subject to and incorporates herein the provisions of the U. S. Department of Housing and Urban Development regulations and the sections of the Code of Federal Regulations that are applicable to said program.

(c) The rules and regulations of the Office of Management and Budget (OMB) Circular A-133 apply. If the Contractor is a non-profit organization incorporated or registered to do business in Pennsylvania under the laws of the Commonwealth of Pennsylvania, Contractor shall provide a copy of its annual Audit or Review, whichever is required to the Pennsylvania Bureau of Charitable Organizations.

(d) If Contractor is a Subrecipient or pass-through entity, Contractor must comply with applicable regulations pertaining to this Agreement.

6. **Insurance.** Contractor will obtain and maintain (a) workers' compensation insurance in accordance with State Workers' Compensation Law; and (b) liability insurance with a combined single limit of not less than \$1,000,000.00 per occurrence with insurers reasonably acceptable to the Authority. Authority will be named as an additional insured on each of such liability policies and such coverage shall be on a primary and non-contributory basis. Contractor will deliver to Authority certificates evidencing such policies prior to the commencement of the Services, and will deliver evidence of the renewal or replacement of such policies at least 30 days prior to the expiration thereof. Each of such policies will contain a waiver of the insurer's rights of subrogation against Authority.

7. **Termination.**

(i) The Authority may terminate this Agreement for convenience upon 30 days' prior written notice to the Contractor.

(ii) This Agreement shall terminate automatically without notice upon the occurrence of any of the following events:

- (a) A material breach of this Agreement by Contractor;
- (b) Contractor or Contractor's employees engaging in conduct materially injurious to the Authority or to itself/themselves, including but not limited to acts of dishonesty or fraud, commission of a felony or a crime of moral turpitude, or alcohol or substance abuse;
- (c) Contractor's refusal to substantially perform the Services;
- (d) Contractor becomes insolvent or makes a general assignment for the benefit of creditors; or
- (e) Contractor files a petition in bankruptcy or such petition is filed against Contractor.

Authority shall be liable only for payment for Services rendered prior to the effective date of termination. If this Agreement is terminated pursuant to subparagraphs (a) or (c) Authority may take over the Services and prosecute the same to completion by contract or otherwise, and Contractor shall be liable for any additional costs incurred by Authority. Authority may

withhold any payments to Contractor, for the purpose of set-off or partial payment, as the case may be, of amounts owed to Authority by Contractor.

8. Minority/Women Participation. Contractor shall use its best efforts to ensure that minority-owned businesses and women's business enterprises shall have the maximum opportunity to participate in the performance of contracts and subcontracts financed, in whole or in part, with federal funds provided under this contract. In this regard, Contractor shall take all necessary steps in accordance with 24 CFR 85.36(e), to ensure that minority-owned businesses and women's business enterprises have the maximum opportunity to compete for and perform contracts. Contractor shall not discriminate on the basis of race, color, national origin or sex in the award and performance of contracts assisted by the U.S. Department of Housing and Urban Development.

Failure of Contractor to carry out the requirements set forth in 24 CFR 85.36(e) shall constitute a breach of contract and, after notification from the U.S. Department of Housing and Urban Development or Authority, may result in termination of this contract or such other remedy as is deemed appropriate.

For the purposes hereof, a minority-owned business shall mean sole proprietorship, partnership or corporation-owned, operated and controlled by minority group members who have at least 51% ownership. The minority group members must have operational control and interest in capital and earnings commensurate with their respective percentage of ownership. Furthermore, to qualify as a minority-owned business, the business must be certified as an MBE by either the City of Pittsburgh, Allegheny County, Commonwealth of Pennsylvania or some other governmental entity whose certification is acceptable to Authority. Minority group members include, but are not limited to, African-Americans, Hispanic Americans, Native Americans, Asian-Pacific Americans, Asian-Indian Americans and Hasidic Jewish American.

A women's business enterprise is defined as a sole proprietorship, partnership or corporation owned, operated and controlled by women who have at least 51% ownership. Women must have operational control and interest in capital and earnings commensurate with their respective percentage ownership. Furthermore, to qualify as a women's business enterprise, the business must be certified as a WBE by either the City of Pittsburgh, Allegheny County, Commonwealth of Pennsylvania or some other governmental entity whose certification is acceptable to Authority.

In the event of a contractor's failure to comply with the equal employment opportunity and affirmative action provisions, including the affirmative action undertaking outlined in its proposal, or with any of the rules, regulations or orders referenced within this contract, HACP, at its discretion, may exercise any one or more of the following rights and remedies:

- i. cancel, terminate or suspend the contract in whole or in part
- ii. recover from the Contractor, by set off against the unpaid portion of the contract, as liquidated damages and not as a penalty, an agreed upon sum for each day that the contractor fails to comply with the contract, the sum being fixed and agreed upon by and between contractor and HACP

because of the impracticability and extreme difficulty of fixing and ascertaining the actual damages which HACP would sustain in the event of such a breach

- iii. such other rights and remedies (which are cumulative and not exclusive) available under applicable law on in equity.

9. **Acceptance of the Services.** Authority has the right to review and/or require correction of any Services provided by Contractor. Contractor shall make any required corrections to any Service within 10 days at no additional charge. The payment of any invoice by Authority does not indicate acceptance of Services provided. Further, the Authority reserves the right at any time to reject or disapprove any Service provided. If Contractor fails to make the necessary corrections within a reasonable time after notice to do so from the Authority, or if the submission of any corrected Service remains unacceptable, the Authority may immediately terminate this Agreement pursuant to paragraph 7(ii)(a) hereof or reduce the hourly rate to reflect the reduced value of the Services provided.

10. **Confidential Information.** Contractor agrees that Contractor will not knowingly reveal to a third party or use for Contractor's own benefit, either during or after the term of this Agreement, without the prior written consent of Authority, any confidential information pertaining to the business and affairs of Authority, its officers, employees and directors obtained while working with Authority except for information clearly established to be in the public record.

11. **Representation and Warranties of Contractor.** Contractor hereby represents and warrants to Authority that Contractor is not a party to or otherwise subject to or bound by any contract, agreement or understanding which would limit or otherwise adversely affect Contractor's ability to perform the Services or which would be breached by Contractor's execution and delivery of this Agreement or by the performance of the Services.

12. **Indemnification.** Contractor agrees to indemnify and hold Authority harmless from any and all claims, damages, liabilities, costs and expenses (collectively "Claims") arising out of or in connection with Contractor's or its employees' performance of the Services on behalf of Authority.

13. **Independent Contractor.** Contractor shall perform the Services hereunder as an independent contractor and not as an agent or employee of the Authority. Contractor shall be responsible for paying any and all required Federal, state or local taxes arising from the performance of the Services. Contractor agrees to remove any employee from the performance of the Services at the request of Authority.

14. **Copyright.** No material produced in whole or in part under this Agreement shall be subject to copyright in the United States or in any other country. Authority shall have unrestricted authority to publish, disclose, distribute, and otherwise use, in whole or in part, any reports, data, or other materials and documentation prepared by Contractor under this Agreement.

15. **Inspections; Work Product.** Pursuant to 24 CFR 85.36(i)(10) and (11), access shall be given by Contractor to Authority, the United States Department of Housing and Urban Development, the Comptroller General of the United States, or any of their duly authorized representatives, to any books, documents, papers, and records of Contractor which are directly pertinent to this Agreement for the purpose of making an audit, examination, excerpts, and transcriptions. All required records shall be retained for three years after Authority makes final payment and all other pending matters on which Contractor performed Services are closed.

All work product produced by Contractor, including Contractor's employees, in accordance with this Agreement shall become the sole property of Authority in perpetuity. "Work product" shall include all records and other documents resulting from the Services performed under this Agreement. It is understood that Authority may reproduce any such work product without modifications and distribute such work product without incurring obligations for additional compensation to Contractor.

16. **Return of Authority Property.** Promptly after termination of this Agreement, Contractor shall return and shall cause its employees to return to Authority all property of the Authority then in Contractor's possession, including without limitation papers, documents, records, files, computer disks and confidential information, and shall neither make nor retain copies of the same. Authority's obligation to make final payment to Contractor following termination, including without limitation accrued but unpaid fees under paragraph 3 hereof, shall be contingent upon Contractor's compliance with this paragraph.

17. **Third Party Solicitation.** Contractor warrants that Contractor has not retained any company, firm or person to solicit or secure this Agreement and has not paid or agreed to pay any company, firm or person any fee, commission, percentage, brokerage fee, gifts, or any other consideration, contingent upon or resulting from the award or making of this Agreement.

18. **Release.** Prior to final payment under this Agreement, or prior to settlement upon termination of this Agreement, and as a condition precedent thereto, Contractor shall execute and deliver to Authority a final release ("**Release**"), in a form acceptable to Authority, of all claims against Authority by Contractor under and by virtue of this Agreement, other than such claims, if any, as may be specifically excepted by Contractor in stated amounts set forth therein.

19. **Disputes.** All disputes arising under or related to this contract, including any claims for damages for the alleged breach thereof which are not disposed of by agreement, shall be resolved under this clause.

- (a) All claims by the Contractor shall be made in writing and submitted to the Contracting Officer for a written decision. A claim by the Authority against the contractor shall be subject to a written decision by the Contracting Officer.
- (b) The Contracting Officer shall, within 30 days after receipt of the request, decide the claim or notify the Contractor of the date by which the decision will be made.
- (c) The Contracting Officer's decision shall be final unless the Contractor

- 1) Appeals in writing to a higher level in the Authority in accordance with the Authority's policy and procedures;
 - 2) Refers the appeal to an independent mediator or arbitrator; or
 - 3) Files suit in a court of competent jurisdiction. Such appeal must be made within 30 days after receipt of Contracting Officer's decision.
- (d) The Contractor shall proceed diligently with performance of this contract, pending final resolution of any request for relief, claim, appeal, or action under or relating to the contract, and comply with any decision of the Contracting Officer.

EXHIBIT A**SCOPE OF SERVICES****1. PROJECT INTENT**

The intent of this RFQ is for hardware, software, installation, maintenance and technical services in connection with HACP's existing Security Camera System installed across 16 sites. Bidder will be responsible for quarterly and annual maintenance, providing support for the camera system in the event of an outage, and any requested moves, adds, and changes (MACs). Bidder to provide response times as defined in this RFQ. All monthly and annual maintenance, and requested spare parts to be on standby shall be included in the Bidders quote. The quote shall be for 3 years of coverage with two 1 year optional extensions.

2. GENERAL INFORMATION

HACP's Security Camera System includes 813 Samsung IP Camera's deployed across the following 16 sites:

See Attachment A to the scope of work for equipment and quantities installed at each site. The camera security system consists of Samsung cameras, Intransa servers and workstations, Alcatel-Lucent Switches, GarrettCom Switches, IFS Media Converters, Altronix equipment, APC UPSs, Motorola Canopy wireless, video monitors, and Milestone XProtect camera management software.

Some equipment is still under warranty through the manufacturer or the original installer. See Attachment B to the scope of work for a list of all equipment and the warranty expiration dates.

HACPs sites have 1Gbps dedicated fiber circuits managed and maintained by Salsgiver, Inc. The 1Gbps circuits are aggregated into a 10Gbps fiber circuit to HACP headquarter's located at 200 Ross Street.

3. SCOPE OF SERVICES

3.1. The Bidder shall provide 24x7x365 support as needed for minor, major, and critical outages. The Bidder shall provide a not-to-exceed troubleshooting cost for each reported outage. The troubleshooting cost shall include all actions taken by the Bidder up to the time of determining the cause of the outage. The cost to repair the equipment shall be billed using the time and material method using unit prices for labor and equipment included in this bid.

3.2. The Bidder shall provide the following maintenance on a quarterly (every 3 months) basis:

3.2.1. Server & workstation software updates – Bidder shall install updates to servers and workstations on a quarterly basis. Bidder shall backup all server images after software updates are applied.

3.2.2. Software and firmware upgrades – Bidder shall check for available upgrades for the cameras, switches, servers, and workstations. Upgrades to the servers and workstations include the Microsoft OS, Microsoft Desktop, Milestone, & VMWare. Once upgrades are identified the Bidder shall provide HACP with a quote for upgrade costs.

3.2.3. Server preventative maintenance – Bidder shall inspect each server for free disk space, error logs, and utilization. Bidder shall physically inspect server for dirt accumulation, fan function, and all other potential environmental issues. Bidder shall provide a quarterly report detailing the findings from these inspections.

3.2.4. Camera view reviews – Bidder shall check each camera view for any viewing issues such as:

- Outages
- Out of focus cameras
- Out of position cameras

Bidder shall provide all findings to HACP in a report due no more than 2 weeks after completion of the review.

3.3. The Bidder shall provide the following maintenance and services on a semi-annual basis:

- 3.3.1. Dome cleaning – Twice a year for outdoor camera's. Dome cleaning shall include wiping the dome internally and externally with a Samsung approved cleaning solution. Bidder shall also clean the interior of the camera (bugs, dirt, debris, etc.).
- 3.4. The Bidder shall provide the following maintenance and services on an annual basis:
 - 3.4.1. Dome cleaning – Once a year for indoor camera's. Dome cleaning shall include wiping the dome internally and externally with a Samsung approved cleaning solution. Bidder shall also clean the interior of the camera (bugs, dirt, debris, etc.).
 - 3.4.2. Tree trimming review – During the month of June the Bidder shall review all outdoor camera views and wireless line of sight for trees and branches that have grown and interfere or may soon interfere with camera views and line of sight between wireless equipment. Once the Bidder identifies trees to be trimmed, the Bidder shall mark each tree and provide HACP with a detailed list and scope of work for each tree (remove, trim, etc.). HACP will coordinate and be responsible for paying a local contractor to perform the work.
 - 3.4.3. Camera system training – Bidder shall provide 16 hours of training per year as requested by HACP to train basic and admin users as needed.
 - 3.4.4. Annual technology review – Bidder will meet with HACP and discuss the current status of HACP equipment and technology options available to HACP.
- 3.5. The Bidder shall store & maintain the following files and information:
 - 3.5.1. Switch Images and configuration files – The current configuration files will be made available to the winning Bidder.
 - 3.5.2. Server Images – Bidder shall backup critical server data (not camera system recordings) and store at an off-site location.
 - 3.5.3. Licenses – Bidder shall maintain all licensing information for all applicable products installed such as but not limited to Microsoft Server, VMWare, Milestone, and Samsung Cameras.
 - 3.5.4. Upgrade Status – Bidder shall maintain a spreadsheet with current software/firmware revisions on installed camera system equipment. This document shall be updated after each upgrade and presented to HACP upon request.
 - 3.5.5. As-Built Documentation – Bidder shall keep all as-built documentation up to date and accurate. This information shall be made available to HACP each time it is updated and upon request. The existing as-built documentation shall be made available to the winning Bidder. Existing as-built documentation is in AutoCAD and Microsoft Excel formats.
- 3.6. Provide optional pricing for warranty coverage through the manufacturer:

Bidder shall provide optional pricing for extended warranty coverage on installed camera system equipment for 3 years. Warranty terms and conditions shall be supplied with warranty pricing. The pricing for extended warranty coverage is optional and to be included as such as part of this bid.

3.7. Provide optional pricing for software assurance through the manufacturer:

Bidder shall provide optional pricing for software assurance (annual fee for software upgrades) for eligible camera system software. The camera system uses the following software:

- Milestone XProtect Corporate 4.1A
- Milestone XProtect SmartWall 1.0B
- Milestone SmartClient 7.0C
- VMWare Player 3.1.1
- Microsoft Server 2008 Standard.

3.8. Support Personnel Certifications

The Bidder shall provide and update as necessary the list of manufacturer certified repair personnel. Certified personnel shall be defined as those repair personnel who have attended the manufacturer's training classes on the type and model equipment installed at the HACP's locations, who have the proper experience and licenses for the work to be performed, and who are recognized by the manufacturer as "qualified" technical support personnel. Only certified repair personnel as described above shall be considered as adequate for response to a failure. Here is a list of manufacturers (hardware and software) that the Bidder and/or sub-contractors used by the Bidder must be certified in:

- 3.8.1. Samsung IP camera's
- 3.8.2. Intransa Servers
- 3.8.3. Milestone XProtect Corporate
- 3.8.4. Alcatel-Lucent Switches
- 3.8.5. Leviton/Superior Essex cabling system (fiber and copper infrastructure)
- 3.8.6. APC UPS's.
- 3.8.7. Microsoft Server 2008 Standard
- 3.8.8. Microsoft Desktop
- 3.8.9. VMWare

3.9. Bidder shall purchase and store a minimum amount of spare parts defined in Attachment C. This equipment shall be used to replace a device upon failure to minimize downtime. If the original product is still under warranty, the Bidder will be required to contact the manufacturer for repair or replacement of the defective device. If a product is no longer covered under warranty and is not repairable, the Bidder shall properly dispose of the equipment and order additional equipment to replenish the stock of stored hardware. All equipment removed from the HACP sites (whether for defective or replaced equipment) shall have the model and serial numbers of the equipment recorded and sent to HACP for inventory control. If the equipment originally stored is no longer available the Bidder shall provide HACP with a quote to replace the hardware with equipment that meets or exceeds the specifications of the original equipment. HACP shall be billed in accordance with the Bidders attached Bill of Materials to replenish the minimum amount of stored hardware required in (Attachment C to the scope of work). Upon completion or termination of the maintenance contract, all stored equipment shall be delivered to HACP.

4. MAJOR & MINOR OUTAGES

4.1. Minor Outage

A minor outage shall be defined as an incident in which 1 - 3 cameras are no longer viewable or recording at any one site.

4.2. Major Outage

A major outage shall be defined as an incident in which 4 or more cameras are no longer viewable or recording at any one site. This includes switch outages as well as backbone cabling damage.

4.3. Critical Outage

A critical outage shall be defined as an incident in which all cameras are no longer viewable or recording at any one site. This includes server or primary switch outages and backbone cabling damage.

5. RESPONSE TIMES & TIMES TO RESOLVE

Once HACP detects an outage and determines if the outage is classified as a minor, major or critical outage, HACP will contact the Bidder. The Bidder must provide HACP with a toll-free number available 24x7x365. The bidder must adhere to the following requirements:

5.1. Minor Outage

The Bidder shall respond within 8 business hours of a reported minor outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 12 business hours unless the cause of the outage is due to cabling damage.

5.2. Major Outage

The Bidder shall respond within 5 hours (business and non-business) of a reported major outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 12 business hours unless the outage is due to cabling damage.

5.3. Critical Outage

The Bidder shall respond within 3 hours (business and non-business) of a reported critical outage. Once the Bidder determines the cause of the outage, the Bidders time to resolve shall be 8 business hours unless the outage is due to cabling damage.

6. PENALTIES

Should the Bidder fail to meet the required response times & times to resolve in this bid the following penalties may be assessed against the Bidder:

- If the Bidder fails to meet the response times response times & times to resolve for a minor, major, or critical outage more than one time in a period of 30 days HACP reserves the right to terminate the maintenance contract with the Bidder.
- If the Bidder fails to meet the response times response times & times to resolve for a minor, major or critical outage the following penalties may be assessed against the Bidder by HACP:
 - 1 – 2 Hours late = \$100 an hour.
 - 3 – 4 Hours late = \$200 + \$200 an hour.
 - > 4 Hours late = \$600 + \$400 an hour.

7. SERVICE CENTER

Bidder shall list the address of the service center that will install and maintain the system and state its boundaries.

8. CABLING DAMAGE

In the event cabling is damaged, the Bidder shall provide a quote to HACP (within 12 business hours of determining the outage is related to damaged cabling) to repair the cabling. All cabling work shall be completed by individuals certified in Leviton/Superior Essex cabling systems. The Bidders quote to repair the cabling must include time to resolve upon acceptance of the quote by HACP. HACP reserves the right to reject any quote and obtain quotes from other contractors certified in Leviton/Superior Essex.

9. MOVES, ADDS AND CHANGES

9.1. Moves, Adds and Changes Requests

Requests for moves, adds and changes shall only be accepted when presented in writing (paper or electronic) from authorized representatives of HACP. HACP will provide the winning Bidder with a list of authorized representatives. Technicians performing moves, adds and changes activity shall respond on-site to complete the work within one week of requested MAC's.

9.2. Moves, Adds and Changes Pricing

The Bidder shall provide as part of the response to this bid, a detailed listing of various moves, adds and changes activities and their approximate costs to be expected if HACP requests work. List of common MAC's associated with the camera system:

- Adding or removing camera's
- Changing a camera view
- Adding or removing camera system users
- Adding switches to support additional camera's
- Installing Milestone software on PC's
- Adding additional wireless equipment
- Connect additional HACP provided equipment to the communications infrastructure.

9.3. Inventory

If any moves, adds and changes activity HACP elects to undertake requires specialized inventory of parts, supplies, or test equipment, the Bidder shall make all such inventory available to HACP at a reasonable cost.

10. IN SCOPE – FIXED PRICING

These services and equipment must be included in the maintenance contract cost:

- 24x7x365 support for troubleshooting outages.
- All quarterly, semi-annual and annual maintenance & services as identified in Section 4.
- Initial cost to purchase all equipment listed in (Attachment C to the scope of work) for spare camera system parts.
- Maintain switch images and configuration files, server images, and as-built documentation.

11. OUT OF SCOPE – TIME & MATERIAL

These services are to be provided on a time and material basis throughout the duration of the maintenance contract:

- 24x7x365 support for repair, MAC's, and administrative assistance with the security camera system.
- Work not covered under manufacturer's warranty on covered equipment.
- Cost to purchase equipment as needed to replenish spare camera system parts.

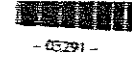

1. Preparation of Offers

(a) Offerors are expected to examine the statement of work, the proposed contract terms and conditions, and all instructions. Failure to do so will be at the offeror's risk.

(b) Each offeror shall furnish the information required by the solicitation. The offeror shall sign the offer and print or type its name on the cover sheet and each continuation sheet on which it makes an entry. Erasures or other changes must be initialed by the person signing the offer. Offers signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the HA.

(c) Offers for services other than those specified will not be considered.

2. Submission of Offers

(a) Offers and modifications thereof shall be submitted in sealed envelopes or packages (1) addressed to the office specified in the solicitation, and (2) showing the time specified for receipt, the solicitation number, and the name and address of the offeror.

(b) Telegraphic offers will not be considered unless authorized by the solicitation; however, offers may be modified by written or telegraphic notice.

(c) Facsimile offers, modifications or withdrawals will not be considered unless authorized by the solicitation.

3. Amendments to Solicitations

(a) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

(b) Offerors shall acknowledge receipt of any amendments to this solicitation by

- (1) signing and returning the amendment;
- (2) identifying the amendment number and date in the space provided for this purpose on the form for submitting an offer,
- (3) letter or telegram, or
- (4) facsimile, if facsimile offers are authorized in the solicitation. The HA/HUD must receive the acknowledgment by the time specified for receipt of offers.

4. Explanation to Prospective Offerors

Any prospective offeror desiring an explanation or interpretation of the solicitation, statement of work, etc., must request it in writing soon enough to allow a reply to reach all prospective offerors before the submission of their offers. Oral explanations or instructions given before the award of the contract will not be binding. Any information given to a prospective offeror concerning a solicitation will be furnished promptly to all other prospective offerors as an amendment of the solicitation, if that information is necessary in submitting offers or if the lack of it would be prejudicial to any other prospective offerors.

5. Responsibility of Prospective Contractor

(a) The HA shall award a contract only to a responsible prospective contractor who is able to perform successfully under the terms and conditions of the proposed contract. To be determined responsible, a prospective contractor must -

- (1) Have adequate financial resources to perform the contract, or the ability to obtain them;

- (2) Have a satisfactory performance record;
- (3) Have a satisfactory record of integrity and business ethics;
- (4) Have a satisfactory record of compliance with public policy (e.g., Equal Employment Opportunity); and
- (5) Not have been suspended, debarred, or otherwise determined to be ineligible for award of contracts by the Department of Housing and Urban Development or any other agency of the U.S. Government. Current lists of ineligible contractors are available for inspection at the HA/HUD.

(b) Before an offer is considered for award, the offeror may be requested by the HA to submit a statement or other documentation regarding any of the foregoing requirements. Failure by the offeror to provide such additional information may render the offeror ineligible for award.

6. Late Submissions, Modifications, and Withdrawal of Offers

(a) Any offer received at the place designated in the solicitation after the exact time specified for receipt will not be considered unless it is received before award is made and it -

- (1) Was sent by registered or certified mail not later than the fifth calendar day before the date specified for receipt of offers (e.g., an offer submitted in response to a solicitation requiring receipt of offers by the 20th of the month must have been mailed by the 15th);
- (2) Was sent by mail, or if authorized by the solicitation, was sent by telegram or via facsimile, and it is determined by the HA/ HUD that the late receipt was due solely to mishandling by the HA/ HUD after receipt at the HA;
- (3) Was sent by U.S. Postal Service Express Mail Next Day Service - Post Office to Addressee, not later than 5:00 p.m. at the place of mailing two working days prior to the date specified for receipt of proposals. The term "working days" excludes weekends and U.S. Federal holidays; or
- (4) Is the only offer received.

(b) Any modification of an offer, except a modification resulting from the HA's request for "best and final" offer (if this solicitation is a request for proposals), is subject to the same conditions as in subparagraphs (a)(1), (2), and (3) of this provision.

(c) A modification resulting from the HA's request for "best and final" offer received after the time and date specified in the request will not be considered unless received before award and the late receipt is due solely to mishandling by the HA after receipt at the HA.

(d) The only acceptable evidence to establish the date of mailing of a late offer, modification, or withdrawal sent either by registered or certified mail is the U.S. or Canadian Postal Service postmark both on the envelope or wrapper and on the original receipt from the U.S. or Canadian Postal Service. Both postmarks must show a legible date or the offer, modification, or withdrawal shall be processed as if mailed late. "Postmark" means a printed, stamped, or otherwise placed impression (exclusive of a postage meter machine impression) that is readily identifiable without further action as having been supplied and affixed by employees of the U.S. or Canadian Postal Service on the date of mailing. Therefore, offerors should request the postal clerk to place a hand cancellation bull's-eye postmark on both the receipt and the envelope or wrapper.

(e) The only acceptable evidence to establish the time of receipt at the HA is the time/date stamp of HA on the offer wrapper or other documentary evidence of receipt maintained by the HA.

(f) The only acceptable evidence to establish the date of mailing of a late offer, modification, or withdrawal sent by Express Mail Next Day Service-Post Office to Addressee is the date entered by the post office receiving clerk on the "Express Mail Next Day Service-Post Office to Addressee" label and the postmark on both the envelope or wrapper and on the original receipt from the U.S. Postal Service. "Postmark" has the same meaning as defined in paragraph (c) of this provision, excluding postmarks of the Canadian Postal Service. Therefore, offerors should request the postal clerk to place a legible hand cancellation bull's eye postmark on both the receipt and the envelope or wrapper.

(g) Notwithstanding paragraph (a) of this provision, a late modification of an otherwise successful offer that makes its terms more favorable to the HA will be considered at any time it is received and may be accepted.

(h) If this solicitation is a request for proposals, proposals may be withdrawn by written notice, or if authorized by this solicitation, by telegram (including mailgram) or facsimile machine transmission received at any time before award. Proposals may be withdrawn in person by a offeror or its authorized representative if the identity of the person requesting withdrawal is established and the person signs a receipt for the offer before award. If this solicitation is an invitation for bids, bids may be withdrawn at any time prior to bid opening.

7. Contract Award

(a) The HA will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the HA, cost or price and other factors, specified elsewhere in this solicitation, considered.

(b) The HA may

- (1) reject any or all offers if such action is in the HA's interest,
- (2) accept other than the lowest offer,
- (3) waive informalities and minor irregularities in offers received, and (4) award more than one contract for all or part of the requirements stated.

(c) If this solicitation is a request for proposals, the HA may award a contract on the basis of initial offers received, without discussions. Therefore, each initial offer should contain the offeror's best terms from a cost or price and technical standpoint.

(d) A written award or acceptance of offer mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer shall result in a binding contract without further action by either party. If this solicitation is a request for proposals, before the offer's specified expiration time, the HA may accept an offer, whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award. 8. Service of Protest

The determination of the HA with regard to such protest or to proceed to award notwithstanding such protest shall be final unless appealed by the protestor.

9. Offer Submission

Offers shall be submitted as follows and shall be enclosed in a sealed envelope and addressed to the office specified in the solicitation. The proposal shall show the hour and date specified in the solicitation for receipt, the solicitation number, and the name and address of the offeror, on the face of the envelope.

The HA shall terminate by delivering to the Contractor a written Notice of Termination specifying the nature, extent, and effective date of the termination. Upon receipt of the notice, the Contractor shall: (i) immediately discontinue all services affected (unless the notice directs otherwise); and (ii) deliver to the HA all information, reports, papers, and other materials accumulated or generated in performing this contract, whether completed or in process.
- (b) If the termination is for the convenience of the HA, the HA shall be liable only for payment for services rendered before the effective date of the termination.
- (c) If the termination is due to the failure of the Contractor to fulfill its obligations under the contract (default), the HA may (i) require the Contractor to deliver to it, in the manner and to the extent directed by the HA, any work as described in subparagraph (a)(ii) above, and compensation be determined in accordance with the Changes clause, paragraph 2, above; (ii) take over the work and prosecute the same to completion by contract or otherwise, and the Contractor shall be liable for any additional cost incurred by the HA; (iii) withhold any payments to the Contractor, for the purpose of off-set or partial payment, as the case may be, of amounts owed to the HA by the Contractor.
- (d) If, after termination for failure to fulfill contract obligations (default), it is determined that the Contractor had not failed, the termination shall be deemed to have been effected for the convenience of the HA, and the Contractor shall be entitled to payment as described in paragraph (b) above.
- (e) Any disputes with regard to this clause are expressly made subject to the terms of clause titled Disputes herein.

~~Section I - Causes for All Non-Construction Contracts greater than \$100,000~~

1. Definitions

The following definitions are applicable to this contract:

- (a) 'Authority or Housing Authority (HA)' means the Housing Authority.
- (b) 'Contract' means the contract entered into between the Authority and the Contractor. It includes the contract form, the Certifications and Representations, these contract clauses, and the scope of work. It includes all formal changes to any of those documents by addendum, Change Order, or other modification.
- (c) 'Contractor' means the person or other entity entering into the contract with the Authority to perform all of the work required under the contract.
- (d) 'Day' means calendar days, unless otherwise stated.
- (e) 'HUD' means the Secretary of Housing and Urban Development, his delegates, successors, and assigns, and the officers and employees of the United States Department of Housing and Urban Development acting for and on behalf of the Secretary.

2. Changes

- (a) The HA may at any time, by written order, and without notice to the sureties, if any, make changes within the general scope of this contract in the services to be performed or supplies to be delivered.
- (b) If any such change causes an increase or decrease in the hourly rate, the not-to-exceed amount of the contract, or the time required for performance of any part of the work under this contract, whether or not changed by the order, or otherwise affects the conditions of this contract, the HA shall make an equitable adjustment in the not-to-exceed amount, the hourly rate, the delivery schedule, or other affected terms, and shall modify the contract accordingly.
- (c) The Contractor must assert its right to an equitable adjustment under this clause within 30 days from the date of receipt of the written order. However, if the HA decides that the facts justify it, the HA may receive and act upon a proposal submitted before final payment of the contract.

4. Examination and Retention of Contractor's Records

- (a) The HA, HUD, or Comptroller General of the United States, or any of their duly authorized representatives shall, until 3 years after final payment under this contract, have access to and the right to examine any of the Contractor's directly pertinent books, documents, papers, or other records involving transactions related to this contract for the purpose of making audit, examination, excerpts, and transcriptions.

- (b) The Contractor agrees to include in first-tier subcontracts under this contract a clause substantially the same as paragraph (a) above. "Subcontract," as used in this clause, excludes purchase orders not exceeding \$10,000.
- (c) The periods of access and examination in paragraphs (a) and (b) above for records relating to:
- (i) appeals under the clause titled Disputes;
 - (ii) litigation or settlement of claims arising from the performance of this contract; or,
 - (iii) costs and expenses of this contract to which the HA, HUD, or Comptroller General or any of their duly authorized representatives has taken exception shall continue until disposition of such appeals, litigation, claims, or exceptions.

5. Rights in Data (Ownership and Proprietary Interest)

The HA shall have exclusive ownership of, all proprietary interest in, and the right to full and exclusive possession of all information, materials and documents discovered or produced by Contractor pursuant to the terms of this Contract, including but not limited to reports, memoranda or letters concerning the research and reporting tasks of this Contract.

6. Energy Efficiency

The contractor shall comply with all mandatory standards and policies relating to energy efficiency which are contained in the energy conservation plan issued in compliance with the Energy Policy and Conservation Act (Pub.L. 94-163) for the State in which the work under this contract is performed.

7. Disputes

- (a) All disputes arising under or relating to this contract, *except for disputes arising under clauses contained in Section III, Labor Standards Provisions*, including any claims for damages for the alleged breach thereof which are not disposed of by agreement, shall be resolved under this clause.
- (b) All claims by the Contractor shall be made in writing and submitted to the HA. A claim by the HA against the Contractor shall be subject to a written decision by the HA.
- (c) The HA shall, with reasonable promptness, but in no event in no more than 60 days, render a decision concerning any claim hereunder. Unless the Contractor, within 30 days after receipt of the HA's decision, shall notify the HA in writing that it takes exception to such decision, the decision shall be final and conclusive.
- (d) Provided the Contractor has (i) given the notice within the time stated in paragraph (c) above, and (ii) excepted its claim relating to such decision from the final release, and (iii) brought suit against the HA not later than one year after receipt of final payment, or if final payment has not been made, not later than one year after the Contractor has had a reasonable time to respond to a written request by the HA that it submit a final voucher and release, whichever is earlier, then the HA's decision shall not be final or conclusive, but the dispute shall be determined on the merits by a court of competent jurisdiction.
- (e) The Contractor shall proceed diligently with performance of this contract, pending final resolution of any request for relief, claim, appeal, or action arising under the contract, and comply with any decision of the HA.

8. Contract Termination; Debarment

A breach of these Contract clauses may be grounds for termination of the Contract and for debarment or denial of participation in HUD programs as a Contractor and a subcontractor as provided in 24 CFR Part 24.

9. Assignment of Contract

The Contractor shall not assign or transfer any interest in this contract, except that claims for monies due or to become due from the HA under the contract may be assigned to a bank, trust company, or other financial institution. If the Contractor is a partnership, this contract shall inure to the benefit of the surviving or remaining member(s) of such partnership approved by the HA.

10. Certificate and Release

Prior to final payment under this contract, or prior to settlement upon termination of this contract, and as a condition precedent thereto, the Contractor shall execute and deliver to the HA a certificate and release, in a form acceptable to the HA, of all claims against the HA by the Contractor under and by virtue of this contract, other than such claims, if any, as may be specifically excepted by the Contractor in stated amounts set forth therein.

11. Organizational Conflicts of Interest

- (a) The Contractor warrants that to the best of its knowledge and belief and except as otherwise disclosed, it does not have any organizational conflict of interest which is defined as a situation in which the nature of work under this contract and a contractor's organizational, financial, contractual or other interests are such that
- (i) Award of the contract may result in an unfair competitive advantage; or
 - (ii) The Contractor's objectivity in performing the contract work may be impaired.
- (b) The Contractor agrees that if after award it discovers an organizational conflict of interest with respect to this contract or any task/delivery order under the contract, he or she shall make an immediate and full disclosure in writing to the Contracting Officer which shall include a description of the action which the Contractor has taken or intends to take to eliminate or neutralize the conflict. The HA may, however, terminate the contract or task/delivery order for the convenience of the HA if it would be in the best interest of the HA.
- (c) In the event the Contractor was aware of an organizational conflict of interest before the award of this contract and intentionally did not disclose the conflict to the Contracting Officer, the HA may terminate the contract for default.
- (d) The terms of this clause shall be included in all subcontracts and consulting agreements wherein the work to be performed is similar to the service provided by the prime Contractor. The Contractor shall include in such subcontracts and consulting agreements any necessary provisions to eliminate or neutralize conflicts of interest.

12. Inspection and Acceptance

- (a) The HA has the right to review, require correction, if necessary, and accept the work products produced by the Contractor. Such review(s) shall be carried out within 30 days so as to not impede the work of the Contractor. Any

product of work shall be deemed accepted as submitted if the HA does not issue written comments and/or required corrections within 30 days from the date of receipt of such product from the Contractor.

- (b) The Contractor shall make any required corrections promptly at no additional charge and return a revised copy of the product to the HA within 7 days of notification or a later date if extended by the HA.
- (c) Failure by the Contractor to proceed with reasonable promptness to make necessary corrections shall be a default. If the Contractor's submission of corrected work remains unacceptable, the HA may terminate this contract (or the task order involved) or reduce the contract price or cost to reflect the reduced value of services received.

13. Interest of Members of Congress

No member of or delegate to the Congress of the United States of America or Resident Commissioner shall be admitted to any share or part of this contract or to any benefit to arise there from, but this provision shall not be construed to extend to this contract if made with a corporation for its general benefit.

14. Interest of Members, Officers, or Employees and Former Members, Officers, or Employees

No member, officer, or employee of the HA, no member of the governing body of the locality in which the project is situated, no member of the governing body in which the HA was activated, and no other public official of such locality or localities who exercises any functions or responsibilities with respect to the project, shall, during his or her tenure, or for one year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.

15. Limitation on Payments to Influence Certain Federal Transactions

(a) Definitions. As used in this clause:

"Agency", as defined in 5 U.S.C. 552(f), includes Federal executive departments and agencies as well as independent regulatory commissions and Government corporations, as defined in 31 U.S.C. 9101(f).

"Covered Federal Action" means any of the following Federal actions:

- (i) The awarding of any Federal contract;
- (ii) The making of any Federal grant;
- (iii) The making of any Federal loan;
- (iv) The entering into of any cooperative agreement, and;
- (v) The extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

Covered Federal action does not include receiving from an agency a commitment providing for the United States to insure or guarantee a loan.

"Indian tribe" and "tribal organization" have the meaning provided in section 4 of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450B). Alaskan Natives are included under the definitions of Indian tribes in that Act.

"Influencing or attempting to influence" means making, with the intent to influence, any communication to or appearance before an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any covered Federal action.

"Local government" means a unit of government in a State and, if chartered, established, or otherwise recognized by a State for the performance of a governmental duty, including a local public authority, a special district, an intrastate district, a council of governments, a sponsor group representative organization, and any other instrumentality of a local government.

"Officer or employee of an agency" includes the following individuals who are employed by an agency:

- (i) An individual who is appointed to a position in the Government under title 5, U.S.C., including a position under a temporary appointment;
- (ii) A member of the uniformed services as defined in section 202, title 18, U.S.C.;
- (iii) A special Government employee as defined in section 202, title 18, U.S.C.; and,
- (iv) An individual who is a member of a Federal advisory committee, as defined by the Federal Advisory Committee Act, title 5, appendix 2.

"Person" means an individual, corporation, company, association, authority, firm, partnership, society, State, and local government, regardless of whether such entity is operated for profit or not for profit. This term excludes an Indian tribe, tribal organization, or other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Recipient" includes all contractors, subcontractors at any tier, and subgrantees at any tier of the recipient of funds received in connection with a Federal contract, grant, loan, or cooperative agreement. The term excludes an Indian tribe, tribal organization, or any other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Regularly employed means, with respect to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, an officer or employee who is employed by such person for at least 130 working days within one year immediately preceding the date of the submission that initiates agency consideration of such person for receipt of such contract, grant, loan, or cooperative agreement. An officer or employee who is employed by such person for less than 130 working days within one year immediately preceding the date of submission that initiates agency consideration of such person shall be considered to be regularly employed as soon as he or she is employed by such person for 130 working days.

"State" means a State of the United States, the District of Columbia, the Commonwealth of Puerto Rico, a territory or possession of the United States, an agency or instrumentality of a State, and a multi-State, regional, or interstate entity having governmental duties and powers.

(b) Prohibition.

- (i) Section 1352 of title 31, U.S.C. provides in part that no appropriated funds may be expended by the recipient of a Federal contract, grant, loan, or cooperative agreement to pay any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any of the following covered Federal actions: the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
- (ii) The prohibition does not apply as follows:

(1) Agency and legislative liaison by Own Employees.

(a) The prohibition on the use of appropriated funds, in paragraph (f) of this section, does not apply in the case of a payment of reasonable compensation made to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, if the payment is for agency and legislative activities not directly related to a covered Federal action.

(b) For purposes of paragraph (b)(i)(1)(a) of this clause, providing any information specifically requested by an agency or Congress is permitted at any time.

(c) The following agency and legislative liaison activities are permitted at any time only where they are not related to a specific solicitation for any covered Federal action:

(1) Discussing with an agency (including individual demonstrations) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and

(2) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.

(d) The following agency and legislative liaison activities are permitted where they are prior to formal solicitation of any covered Federal action:

(1) Providing any information not specifically requested but necessary for an agency to make an informed decision about initiation of a covered Federal action;

(2) Technical discussions regarding the preparation of an unsolicited proposal prior to its official submission; and

(3) Capability presentations by persons seeking awards from an agency pursuant to the provisions of the Small Business Act, as amended by Public Law 95-507 and other subsequent amendments.

(e) Only those activities expressly authorized by subdivision (b)(ii)(1)(a) of this clause are permitted under this clause.

(2) Professional and technical services.

(a) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply in the case of-

(i) A payment of reasonable compensation made to an officer or employee of a person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action, if payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action.

(ii) Any reasonable payment to a person, other than an officer or employee of a

person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action if the payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action. Persons other than officers or employees of a person requesting or receiving a covered Federal action include consultants and trade associations.

(b) For purposes of subdivision (b)(ii)(2)(a) of clause, "professional and technical services" shall be limited to advice and analysis directly applying any professional or technical discipline.

(c) Requirements imposed by or pursuant to law as a condition for receiving a covered Federal award include those required by law or regulation, or reasonably expected to be required by law or regulation, and any other requirements in the actual award documents.

(d) Only those services expressly authorized by subdivisions (b)(ii)(2)(a)(i) and (ii) of this section are permitted under this clause.

(ii) Selling activities by independent sales representatives.

(c) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply to the following selling activities before an agency by independent sales representatives, provided such activities are prior to formal solicitation by an agency and are specifically limited to the merits of the matter:

(i) Discussing with an agency (including individual demonstration) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and

(ii) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.

(d) Agreement. In accepting any contract, grant, cooperative agreement, or loan resulting from this solicitation, the person submitting the offer agrees not to make any payment prohibited by this clause.

(e) Penalties. Any person who makes an expenditure prohibited under paragraph (b) of this clause shall be subject to civil penalties as provided for by 31 U.S.C. 1352. An imposition of a civil penalty does not prevent the Government from seeking any other remedy that may be applicable.

(f) Cost Allowability. Nothing in this clause is to be interpreted to make allowable or reasonable any costs which would be unallowable or unreasonable in accordance with Part 31 of the Federal Acquisition Regulation (FAR), or OMB Circulars dealing with cost allowability for recipients of assistance agreements. Conversely, costs made specifically unallowable by the requirements in this clause will not be made allowable under any of the provisions of FAR Part 31 or the relevant OMB Circulars.

16. Equal Employment Opportunity

During the performance of this contract, the Contractor agrees as follows:

- (a) The Contractor shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin.
- (b) The Contractor shall take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to (1) employment; (2) upgrading; (3) demotion; (4) transfer; (5) recruitment or recruitment advertising; (6) layoff or termination; (7) rates of pay or other forms of compensation; and (8) selection for training, including apprenticeship.
- (c) The Contractor shall post in conspicuous places available to employees and applicants for employment the notices to be provided by the Contracting Officer that explain this clause.
- (d) The Contractor shall, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin.
- (e) The Contractor shall send, to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, the notice to be provided by the Contracting Officer advising the labor union or workers' representative of the Contractor's commitments under this clause, and post copies of the notice in conspicuous places available to employees and applicants for employment.
- (f) The Contractor shall comply with Executive Order 11246, as amended, and the rules, regulations, and orders of the Secretary of Labor.
- (g) The Contractor shall furnish all information and reports required by Executive Order 11246, as amended and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto. The Contractor shall permit access to its books, records, and accounts by the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (h) In the event of a determination that the Contractor is not in compliance with this clause or any rule, regulation, or order of the Secretary of Labor, this contract may be canceled, terminated, or suspended in whole or in part, and the Contractor may be declared ineligible for further Government contracts, or federally assisted construction contracts under the procedures authorized in Executive Order 11246, as amended. In addition, sanctions may be imposed and remedies invoked against the Contractor as provided in Executive Order 11246, as amended, the rules, regulations, and orders of the Secretary of Labor, or as otherwise provided by law.
- (i) The Contractor shall include the terms and conditions of this clause in every subcontract or purchase order unless exempted by the rules, regulations, or orders of the Secretary of Labor issued under Executive Order 11246, as amended, so that these terms and conditions will be binding upon each subcontractor or vendor. The Contractor shall take such action with respect to any subcontractor or purchase order as the Secretary of Housing and Urban Development or the Secretary of Labor may direct as a means of enforcing such provisions, including sanctions for noncompliance; provided that if the Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the Contractor may request the United States to enter into the litigation to protect the interests of the United States.

17. Dissemination or Disclosure of Information

No information or material shall be disseminated or disclosed to the general public, the news media, or any person or organization without prior express written approval by the HA.

18. Contractor's Status

It is understood that the Contractor is an independent contractor and is not to be considered an employee of the HA, or assume any right, privilege or duties of an employee, and shall save harmless the HA and its employees from claims suits, actions and costs of every description resulting from the Contractor's activities on behalf of the HA in connection with this Agreement.

19. Other Contractors

HA may undertake or award other contracts for additional work at or near the site(s) of the work under this contract. The contractor shall fully cooperate with the other contractors and with HA and HUD employees and shall carefully adapt scheduling and performing the work under this contract to accommodate the additional work, heeding any direction that may be provided by the Contracting Officer. The contractor shall not commit or permit any act that will interfere with the performance of work by any other contractor or HA employee.

20. Liens

The Contractor is prohibited from placing a lien on HA's property. This prohibition shall apply to all subcontractors.

21. Training and Employment Opportunities for Residents in the Project Area (Section 3, HUD Act of 1968; 24 CFR 135)

- (a) The work to be performed under this contract is subject to the requirements of section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u (section 3). The purpose of section 3 is to ensure that employment and other economic opportunities generated by HUD assistance or HUD-assisted projects covered by section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD assistance for housing.
- (b) The parties to this contract agree to comply with HUD's regulations in 24 CFR Part 135, which implement section 3. As evidenced by their execution of this contract, the parties to this contract certify that they are under no contractual or other impediment that would prevent them from complying with the Part 135 regulations.
- (c) The contractor agrees to send to each labor organization or representative of workers with which the contractor has a collective bargaining agreement or other understanding, if any, a notice advising the labor organization or workers' representative of the contractor's commitments under this section 3 clause, and will post copies of the notice in conspicuous places at the work site where both employees and applicants for training and employment positions can see the notice. The notice shall describe the section 3 preference, shall set forth minimum number and job titles subject to hire, availability of

apprenticeship and training positions, the qualifications for each; and the name and location of the person(s) taking applications for each of the positions; and the anticipated date the work shall begin.

- (d) The contractor agrees to include this section 3 clause in every subcontract subject to compliance with regulations in 24 CFR Part 135, and agrees to take appropriate action, as provided in an applicable provision of the subcontract or in this section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 CFR Part 135. The contractor will not subcontract with any subcontractor where the contractor has notice or knowledge that the subcontractor has been found in violation of the regulations in 24 CFR Part 135.
- (e) The contractor will certify that any vacant employment positions, including training positions, that are filled (1) after the contractor is selected but before the contract is executed, and (2) with persons other than those to whom the regulations of 24 CFR Part 135 require employment opportunities to be directed, were not filled to circumvent the contractor's obligations under 24 CFR Part 135.
- (f) Noncompliance with HUD's regulations in 24 CFR Part 135 may result in sanctions, termination of this contract for default, and debarment or suspension from future HUD assisted contracts.

22. Procurement of Recovered Materials

- (a) In accordance with Section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act, the Contractor shall procure items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition. The Contractor shall procure items designated in the EPA guidelines that contain the highest percentage of recovered materials practicable unless the Contractor determines that such items: (1) are not reasonably available in a reasonable period of time; (2) fail to meet reasonable performance standards, which shall be determined on the basis of the guidelines of the National Institute of Standards and Technology, if applicable to the item; or (3) are only available at an unreasonable price.
- (b) Paragraph (a) of this clause shall apply to items purchased under this contract where: (1) the Contractor purchases in excess of \$10,000 of the item under this contract; or (2) during the preceding Federal fiscal year, the Contractor: (i) purchased any amount of the items for use under a contract that was funded with Federal appropriations and was with a Federal agency or a State agency or agency of a political subdivision of a State; and (ii) purchased a total of in excess of \$10,000 of the item both under and outside that contract.

If HUD 5370-C applies:

Section 1 Item 7(d) of the General Conditions shall be deleted in its entirety and replaced by the following:

Section 1 Item 7(d). Forum. The Contracting Officer's decision shall be final unless, within thirty (30) days of receipt of the Contracting Officer's decision, the Contractor files suit in a court of competent jurisdiction.

- (d) The Contractor shall require a disclosure or representation from subcontractors and consultants who may be in a position to influence the advice or assistance rendered to the HA and shall include any necessary provisions to eliminate or neutralize conflicts of interest in consultant agreements or subcontracts involving performance or work under this Contract.

5. Authorized Negotiators (RFPs only)

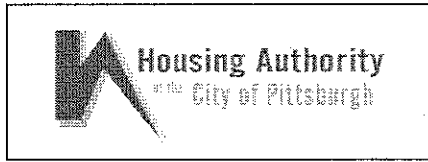
