ADDENDUM NO.1

This addendum issued February 11, 2014 becomes in its entirety a part of the Invitation for Bid IFB#300-03-14 as is fully set forth herein:

Item 1: Q: Your current specification is requiring galvanized steel products. Is you agency receptive to alternative products?

A: Alternatives must be submitted for approval February 14, 2014 at 10:00 AM (include spec sheets).

Item 2: Q: Will aluminum frame products with Stainless steel wire become an acceptable alternative?

Item 3: Q: Do all of the windows require egress?

Item 5: Q: Is there a performance standard or rating standard for benchmark performance that is being considered?

Item 12: Q: We just had a questions for billing on page 31. We broke up the actual equipment list to further clarify the equipment to be billed. We also added an installation and removal charge for the Steel Doors and Screens. The alarms are actually billed by the main PAU unit which receives the signals from the PIR sensors that actually activates the alarms. The alarm uses GSM (cell signals) to transmit so there is no need for wires. Also, it is battery operated so you will not need power. Based on how the technology works, the PIRs and PIR Cameras work by line of sight. So, therefor, you do not have to put an alarm PIR on every window. The alarms will just have an installation fee on them.
