The mesh should provide open wi-fi access for 802.11b, g, n, ac. The mesh should allow at least 20 connections to any single access point and at least 50 connections over the mesh. The mesh should provide 50mb bandwidth to the connected devices.

The mesh should provide coverage in four (4) areas, inside the Northview Heights Gym, inside the Highrise Lobby and Community Room, outside in the Northview Heights Playground, and outside at the Hazlett Street and Mt. Pleasant Street bus stop.

Location A (Star) – The Comcast internet connection is located in the Resident Council office on the first floor of the Highrise at roughly the location indicated by the star. The Highrise lobby and Community Room is also on the first floor of the building just inside the main building entrance seen just below the star.

Location C – is the bus stop at Hazlett Street and Mt. Pleasant Street.

Location D – is the Northview Heights Playground.
