This addendum issued December 26, 2018 becomes in its entirety a part of the 3 Quote Bid as is fully set forth herein:


Item 1: **Q:** The Quote Request is to identify hazardous materials (ACM tile and mastic) at various locations to determine if ACM is identified, and if ACM is identified, to perform final clearance air monitoring following asbestos abatement. However, the Quote Request is asking for a "Total Cost." Should the Total Cost be broken down into a "Unit Cost" for surveying and testing one unit for ACM tile and mastic and a "Unit Cost" for final clearance air monitoring?

Unless we know how many units will need to be inspected for ACM tile and mastic and how many units will require final clearance air monitoring, there's no way to give a Total Cost for our services.

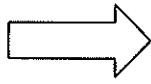
