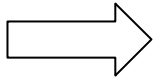

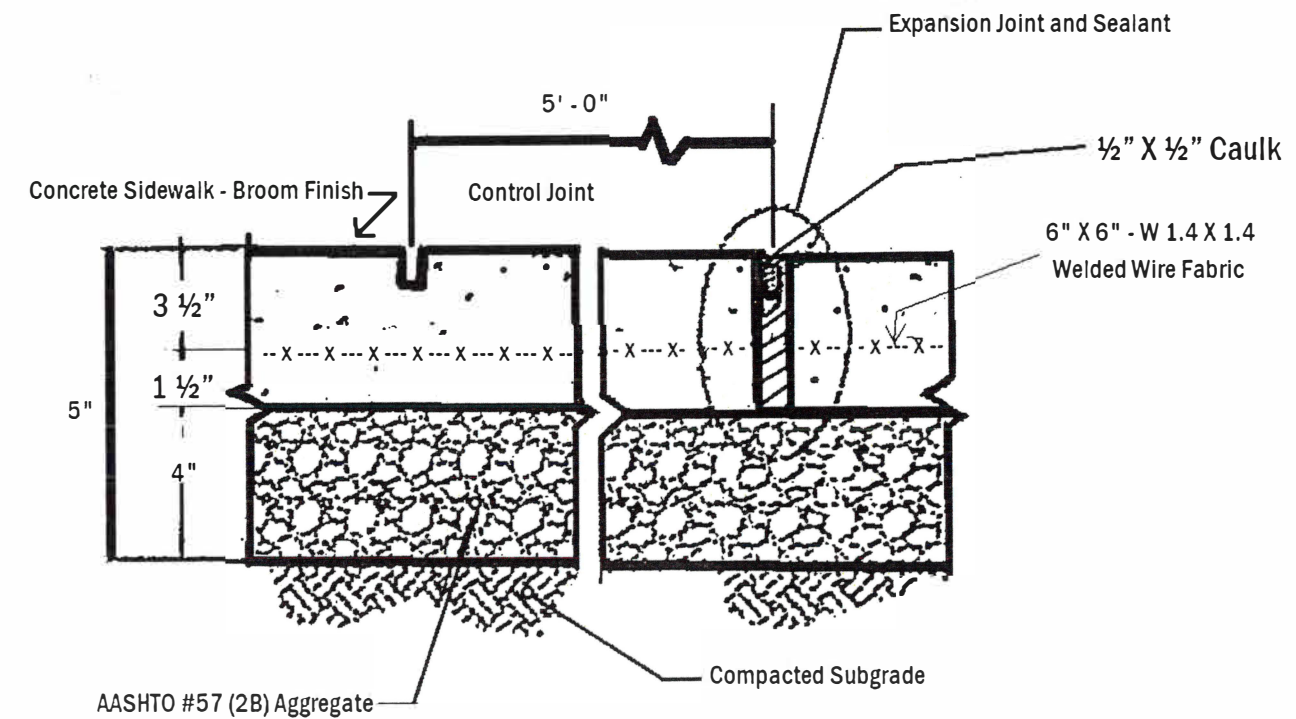
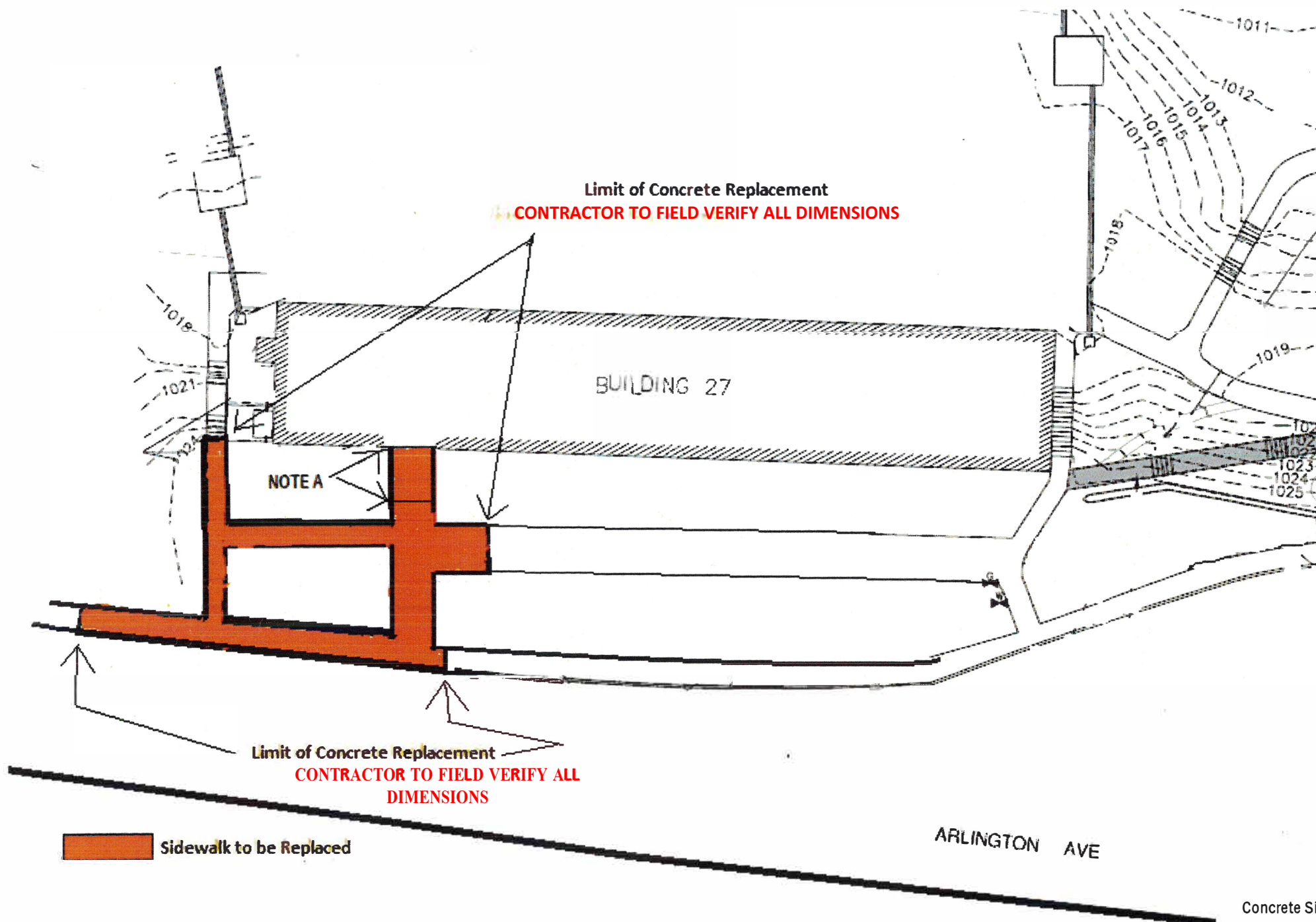
NOTES FOR CONCRETE WORK AT BLDG. 27

Demolish and Properly Dispose of Existing Temporary Bridge

1. Demolish existing concrete sidewalks as shown for concrete Sidewalk to be Replaced.
2. New concrete sidewalks to be replaced must have a minimum of ¼ inch/foot positive drainage away from the building. **CONTRACTOR TO FIELD VERIFY ALL DIMENSIONS**
3. Sidewalk base to be a minimum of 4 inches of #57 aggregate.
4. New concrete sidewalks to be 3000 PSI.
5. Expansion joints to be 20 feet maximum.
6. Weakened plane construction joints to be at 5' - 0" intervals.
7. All new concrete sidewalks to receive two coats of Acrylic Sealer (Hardener & Dust-proofer type). USA PS102 Siliconate Sealer by Concrete Sealers USA or approved equal
8. All areas disturbed by the sidewalks construction to receive topsoil and seeding.

NOTE A

The initial 10 feet of sidewalk starting at the building entry is required to have expansion joints at the building entry and 10 feet from the building (moving towards Arlington Avenue).
