ADDENDUM NO.5

This addendum issued June 2, 2020 becomes in its entirety a part of the Invitation for Bid IFB #600-15-20 as is fully set forth herein:

Item 1:

The following changes are additions and clarifications to the original drawings and shall become a part of the Contract Documents. They are intended to supersede and supplement the Construction Documents and Written Specifications dated **March 11, 2020.** All Contractors and Suppliers shall read all Addendum items and their relation to each portion of the work.

1. SPECIFICATIONS - C902

a) Paragraph 42 - CLEAN FILL. Strike the words "DREDGED MATERIAL, USED ASPHALT, AND BRICK, BLOCK OR CONCRETE FROM CONSTRUCTION AND DEMOLITION ACTIVITIES THAT IS SEPARATE FROM OTHER WASTE AND IS RECOGNIZABLE AS SUCH" AND "(THE TERM "USED ASPHALT" DOES NOT INCLUDE MILLED ASPHALT OR ASPHALT THAT HAS BEEN PROCESSED FOR RE-USE)". The new paragraph shall read as follows: "42. CLEAN FILL: UNCONTAMINATED, NON-WATER SOLUBLE, NON-DECOMPOSABLE, INERT, SOLID MATERIAL. THE TERM INCLUDES SOIL, ROCK, AND STONE. THE TERM DOES NOT INCLUDE MATERIALS PLACED IN OR ON THE WATERS OF THE COMMONWEALTH UNLESS OTHERWISE AUTHORIZED."

2. DEMOLITION PLAN - A2

a) GENERAL DEMOLITION NOTES. Append the following to the GENERAL DEMOLITION NOTES as note 11 "As required under City of Pittsburgh

Demolition Permit, Demolition Contractor shall be responsible for appropriately treating the property for pests and rodents and obtaining certification stating the same in a form acceptable to Pittsburgh Department of Licenses and Permits (PLI)."

Item 2:

Due to the COVID-19 Pandemic, The Housing Authority of the City of Pittsburgh will only be accepting physical bids dropped off in person from 8:00 AM until the bid opening time of 10:00 AM on June 9, 2020 in the lobby of 100 Ross St. Pittsburgh, PA 15219. Sealed bids may still be mailed via USPS at which time they will be Time and Date Stamped at 100 Ross Street 2nd Floor, Suite 200, Pittsburgh, PA 15219. All bids must be received at the above address no later than June 9, 2020 at 10:00 a.m., regardless of the selected delivery mechanism.

The proposal due date, time, and location changed at June 9, 2020, at 10:00 AM, at the lobby area of 100 Ross St., Pittsburgh, PA, 15219.
