Provide maintenance for 12 Emergency Generators and the 4 Fire Pumps base on one (1) visit per unit and emergency repair service.

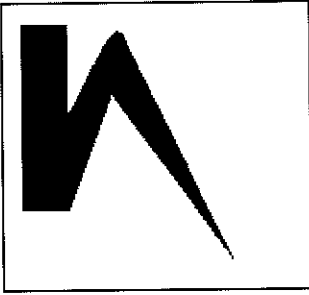
A written report along with the maintenance checklists are to be sent to the Engineering Department upon completion of each unit.
