## Housing Authority of the City of Pittsburgh BOARD OF COMMISSIONERS <u>MEETING MINUTES</u> MAY 28, 2020 VIA ZOOM CONFERENCING

# **RESOLUTION No. 19 of 2020**

# A Resolution - Authorizing the Executive Director or his Designee to Award a Contract to Water Transfer Solutions Inc. for Vacant Lot Land Care Services in the Middle Hill District for the Housing Authority of the City of Pittsburgh

**WHEREAS**, the Housing Authority City of Pittsburgh (HACP) owns several vacant lots within the city of Pittsburgh which require maintenance; and

**WHEREAS**, on March 15, 2020 the HACP issued an Invitation for Bid (IFB # 300-05-20) for Grass Cutting of Vacant Lots in the Middle Hill; and

WHEREAS, Water Transfer Solutions Inc. submitted the lowest, responsive proposal; and

**WHEREAS**, HACP provided a list of vacant lots to Water Transfer Solutions Inc. (attached) for vacant lot land care services in the Middle Hill District; and

**WHEREAS**, Water Transfer Solutions Inc. submitted a proposal in the amount of \$373,273.60 for land care services for a term of 1 (one) year initial term, with 2 (two) one-year extension options for a total of 3 (three) years: and

**WHEREAS**, upon completion of the initial 1 (one) year term, the contract will be reviewed for performance prior to execution of each of the option years; and

**WHEREAS**, this procurement was conducted in accordance with applicable federal, state and local procurement rules and regulations and the procurement policies and procedures of the HACP.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Housing Authority of the City of Pittsburgh:

**Section 1.** The Executive Director or his Designee is hereby authorized enter into a contract with Water Transfer Solutions Inc. for Grass Cutting of Vacant Lots in the Middle Hill District; and

**Section 2**. The maximum amount approved by this resolution is \$373,273.60 for 1 (one) year with (2) two (1) one year extensions for a total of (3) three years; and

**Section 3.** The amount shall be paid from program income and/or Moving-to-Work (MTW) funds.

## **RESOLUTION No. 20 of 2020**

### A Resolution – Authorizing Payment of Partial Predevelopment Costs to Amani Christian Community Development Corporation (ACCDC) for the Turnkey Development in the Middle Hill District

**WHEREAS**, on May 22, 2015 the Housing Authority of the City of Pittsburgh (HACP) awarded Amani Christian Community Development Corporation (ACCDC) a contract for the turnkey development of twenty-two (22) new construction scattered site units located in the Middle Hill District (Project); and

**WHEREAS**, the HACP Board Resolution No. 48 of 2016 approved a total development budget of \$6,300,111.00 for the Project (Project Budget); and

**WHEREAS**, the ACCDC's development proposal included working off of the HACP's inventory of vacant parcels which were then available for the Project and selective Urban Redevelopment Authority (URA) vacant parcels as approved by the HACP; and

WHEREAS, the HACP parcels 10-J-6; 10-J-7; 10-J-7-A; 10-J-9; 9-S-38 and 9-S-37 were later rescinded from the Project due to a duplication of efforts targeted for the parcels (Canceled Parcels), and

**WHEREAS**, the ACCDC conducted predevelopment activities associated with the Canceled Parcels that are no longer available for the project as a result of the HACP's delayed decision on the Canceled Parcels (Partial Predevelopment Costs); and

**WHEREAS**, the ACCDC incurred \$106,115.38 for Partial Predevelopment Costs relating to the predevelopment activities including the environmental assessment, soil investigations, schematic design and project management expenses that were associated with the Canceled Parcels; and

**WHEREAS**, as a small faith-based, community-based nonprofit entity, the ACCDC has requested reimbursement for the Partial Predevelopment Costs prior to the Project's financial closing in order to sustain ongoing predevelopment activities.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Housing Authority of the City of Pittsburgh that:

**Section 1.** The Executive Director or his Designee is hereby authorized to pay the Partial Predevelopment Costs in the amount of up to \$106,115.38 to the ACCDC for the costs incurred on the Canceled Parcels; and

**Section 2**. The Partial Predevelopment Costs shall be paid from Program Income funds and/or Moving to Work (MTW) funds.

# **RESOLUTION No. 21 of 2020**

## A Resolution - Authorizing the Executive Director or his Designee to Enter Into an Intergovernmental Agreement with the Pittsburgh Public Schools (PPS) for the purchase of Laptops or Chrome Books for school-aged children in the Housing Authority of the City of Pittsburgh's (HACP) family communities; and a Contract with Comcast Cable to provide internet services for the recipients of those Laptops or Chrome Books

**WHEREAS**, the Housing Authority City of Pittsburgh (HACP) wants to assist its residents in bridging the digital divide. The HACP has partnered with the Pittsburgh Public Schools (PPS) to provide Laptops and or Chrome books to children in the HACP family communities; and

**WHEREAS**, the HACP provided PPS a list of all family community addresses. The PPS cross-referenced this list to achieve an active list of HACP students attending public schools; and

**WHEREAS**, the HACP has partnered with the PPS, Heinz Endowments, Grable Foundation, Funds for Excellence, Neighborhood Allies, and the Hillman Foundation to accomplish these educational goals; and

**WHEREAS**, the HACP agrees to pay the PPS \$275,000.00 for the purchase of Laptops and Chrome Books to be distributed to school-aged children living in the HACP family communities; and

**WHEREAS**, the HACP agrees to pay Comcast Cable up to \$100,000.00 for the Internet services of Laptops and Chrome Books distributed to school-aged children living in the HACP family communities; and

**WHEREAS**, the HACP has partnered with the PPS in the past. The U.S. Department of Housing and Urban Development (HUD) authorizes the use of intergovernmental agreements and has issued regulations governing such agreements; and

**WHEREAS**, this procurement was conducted in accordance with applicable federal, state, and local procurement rules and regulations and the procurement policies and procedures of the HACP.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Housing Authority of the City of Pittsburgh:

**Section 1.** The Executive Director or his Designee is hereby authorized to Enter Into an Intergovernmental Agreement with the Pittsburgh Public Schools (PPS) for the purchase of Laptops or Chrome Books and to enter into a contract with Comcast Cable to provide internet services for the recipients of those Laptops or Chrome Books; and

**Section 2**. The maximum amount approved for the PPS contract by this resolution is \$275,000.00; and

**Section 3.** The maximum amount approved for the Comcast Cable contract by this resolution is \$100,000.00; and

**Section 4.** The amount designated shall be paid from program income and/or Moving-To-Work (MTW) funds and/or COVID-19 funds.
