Item 1: Q: On page 34,35 are we just supposed to put the hourly rate that we are bidding?
A: Yes.

Item 2: Q: On page 69, 70, and 72 not sure what we to do?
A: All prospective bidders must complete a Section 3 plan that can be found on pages 68-70. You are required to pick a Tier! There are four Tiers, **Tier I** Hiring; this is where the contractor will contact me about any open positions. **Tier II** is contracting with a Section 3 certified Business, **Tier III** OTHER ECONOMIC OPPORTUNITIES, **Tier IV** No New Hire Opportunity.

Pg. 69 is only if you are looking to hire! The Section 3 Labor Utilization Assessment and Plan is where you will mark down the # of your current staff (Job Title) if you are looking for hire's, where it states (NEEDED) you will mark down the number of mechanics.

Pg. 72 relates to the MBE/WBE goals program. Fill that chart out with the names and the commitment percentages of any of the MBE/WBE subs you have chosen to partner with.

Item 3: The bid due date is changed to November 10, 2020; time and location remain unchanged at 10:00 AM, at the HACP Procurement Dept., 100 Ross St. 2nd Floor, Suite 200, Pittsburgh, PA 15219.

Item 4: The Housing Authority of the City of Pittsburgh will **only be accepting physical proposals dropped off in person from 8:00 AM until the bid opening time of 10:00 AM** on November 10, 2020 in the lobby of 100 Ross St. Pittsburgh, PA 15219. Proposals may still be
