- **Item 1:** Q: Do you anticipate extending the bid due date?

 - A: This bid will be awarded to the highest scoring responsive and responsible offeror which is most advantageous to The Authority.

 - A: HACP has no relation nor any control over what is published on websites other than www.hacp.org. A legal advertisement was place with the Pittsburg Post-Gazette, the New Pittsburgh Courier, and the Pittsburgh Business Times.
- **Item 5:** Q: Is there a list of firms that are MBE/WBE owned that perform this type of work? We are aware that some of this information may be housed on the PA UCP site, but are curious if you are aware of any additional resources. Please let me know if something like this exists.
 - A: To our knowledge, there is no master "list" of all MBE/WBE certified firms that perform a specific service. HACP will accept any <u>third party certification</u> from a reputable source.
- **Item 6:** The proposal due date, time, and location remain unchanged at December 22, 2020 at 10:00 AM, at the HACP Procurement Dept., 100 Ross St. 2nd Floor, Suite 200, Pittsburgh, PA 15219.
