## ADDENDUM NO.1

This addendum issued January 11, 2021 becomes in its entirety a part of the 3 Quote Bid as is fully set forth herein:

**Item 1:** Q: In the procurement request there is a mention of HUD MAP experience; however, it appears that the appraisal report will only be submitted to PHFA. Can you confirm that the scope of work will only be to PHFA standards and that this appraisal report is not intended to be HUD MAP compliant?

A: The scope of work must conform to Tab 7 of the Pennsylvania Housing Finance Agency Multifamily Application. HACP may or may not intended to meet the requirements of the U.S. Department of Housing and Urban Development Multifamily Accelerated Processing program standards. Offerors should indicate their experience with the program in their response.

**Item 2:** Q: The PHFA filing deadline is February 5<sup>th</sup>. In the procurement request you mention delivery within three weeks of engagement; however, that looks like that would put delivery after the deadline. When would you need the reports in hand to ensure you can hit the PHFA deadline?

A: The referenced February 5<sup>th</sup> filing deadline pertains to the Pennsylvania Housing Finance Agency's 9% Low Income Housing Tax Credit application, and not applicable to this 3 Quote Bid request. The project does not apply for 9% LIHTC.

Item 3: Q: Do you anticipate extending the bid due date?

A: Please See Item 7 for the bid due date.

**Item 4:** Q: What additional details are you willing to provide, if any, beyond what is stated in bid documents concerning how you will identify the winning bid?


A: This bid will be awarded to the lowest responsive and responsible bidder which is most advantageous to ARMDC.
