- **Item 1:** Q: Would it be possible to share 2 years of audited financial statements for Allies & Ross Management and Development Corporation?
- A: The financials will be provided to the selected investor at the completion of the procurement process.
- **Item 2:** Q: Would you be able to confirm that all of the units will receive ACC subsidy or will they have another subsidy?
- A: The units will be funded through the Housing Authority of the City of Pittsburgh (HACP) Annual Contributions Contract (ACC) with the U.S Department of Housing and Urban Development. The project will not have a mortgage from a private lender. All permanent debt on the project is currently envisioned to come from its development instrumentality, Allies & Ross Management and Development Corporation (ARMDC) and/or HACP.
- **Item 3:** Q: When will the GAP Loan financing come in? We see in the RFP it comes in at conversation if so do you have another source of fincancing through construction? If not our LTV does not size to the construction loan requested in the RFP.
- A: The timing of the gap loan can be adjusted depending on the need of the project. If needed, an equity bridge loan may also be considered.
- **Item 4:** Q: What Cap Rate are you assuming?

A: 6%
