ADDENDUM NO.2

This addendum issued March 10, 2021 becomes in its entirety a part of the Invitation for Bids IFB #650-15-21 as is fully set forth herein:

- Item 1: Q: There is an issue with item 1 on the contract. The only pant available in a natural color is the Dickies 1953NT Natural Painter Pant which does not compare to the Carhartt pant in the specs. The 1953 is an all Cotton Pant and has none of the additional pockets that are on the Carhartt Pant. And if you decide to do white the color listed for this item on Page 32 of your specs. You will have some other options but again nothing will be an exact match. If you are dead set on the Carhartt pant your best option would be to spec the color as Khaki
 - A: The color can be white or natural as long as they are cargo style with ample pockets.
- **Item 2:** Q: The pant you have chosen only comes up to waist sizes 46 and is even more limited as a number of sizes are only available in inseam lengths of 30 and 32. I would estimate this will effect between 20 to 25 percent of your employees
 - A: If an equivalent is available please include the sample and specifications with your bid.
- It may be too late to change your specs but, based on my experience in this business I would suggest the PT2A pant from Red Kap in Navy and Khaki. It is a stretch canvas with multiple pockets, reinforced knees and is available up to size 50 waist size and lengths in all sizes up to 36. If you want to check it out here is a website to go to:

- A: If this is equal or equivalent please include the sample and specifications with your bid.
- **Item 4:** Q: You have indicated the item is a 3 in 1 Jacket but if you go by the description the item it corresponds to is not a 3 in 1 Jacket
 - A: Core 365 or Equivalent #88205

Item 5: The proposal due date time, and location remain unchanged at March 16, 2021 at 9:00 AM, at the HACP Procurement Dept., 100 Ross St. 2nd Floor, Suite 200, Pittsburgh, PA 15219.

Item 6: The Housing Authority of the City of Pittsburgh will only be accepting physical proposals dropped off in person from 8:00 AM until the closing time of 9:00 AM on March 16, 2021 in the lobby of 100 Ross St. Pittsburgh, PA 15219. Proposals may still be submitted electronically: IFB #650-15-21 Uniforms for HACP Employees and may still be mailed via USPS at which time they will be Time and Date Stamped at 100 Ross Street 2nd Floor, Suite 200, Pittsburgh, PA 15219.
