ADDENDUM NO.1

This addendum issued April 20, 2021 becomes in its entirety a part of the Invitation for Bids IFB #300-18-21 as is fully set forth herein:

Item 1: Q: For Section 3 – In particular the section stating that as the contractor we have to hire a percentage of the contract award a resident. What is the process for that? Is this just a good faith effort?

A: The required percentage is 30% if the contractor is looking to choose Tier 1, also the contractor will contact me (Resident Employment Program) to discuss hiring and interviewing possible Section 3 workers. No, the contractor should review the Section 3 Opportunities plan and review the Tiers and select a Tier that best reflects the company's intention to provide the greatest extent feasible.

Item 2: Q: It only states estimated hours that we can use to bid off of. Do you have actual counts of devices that you can send out for us to quote off of.
