The Housing Authority of the City of Pittsburgh (HACP) seeks to engage a qualified vendor to perform Professional Environmental Services to conduct sub-slab vapor encroachment testing and near surface soil gas sampling in the Manchester neighborhood of the City of Pittsburgh, Allegheny County, Pennsylvania. HACP requests testing to be performed for six (6) scattered site properties in Manchester to confirm any potential vapor intrusion concern identified in the previously conducted report completed by Professional Service Industries, Inc. in June 2021. This report can be provided to the selected vendor for reference.

The selected vendor shall conduct testing, which will include field inspections/sampling activities to be performed in accordance with EPA and HUD Regulations & Guidelines.

The basements of two (2) properties located at 1132 Sheffield Street and 1134 Sheffield Street contain a soil covering; therefore, near surface soil gas sampling will be required for these units.

The selected vendor shall generate a final report which will include, but is not limited to; the test results, methodology, recommendations for remediation (if necessary), and a cost estimate based on the results.

All services performed must be in compliance with all applicable local, state, and federal laws and regulations including, but not limited to, Handicap Accessibility (Section 504), Americans with Disabilities Act (ADA), Uniform Federal Accessibility Standards (UFAS), Davis-Bacon and minimum wage requirements, and Federal procurement requirements. In addition, all services must be performed in compliance with all applicable Commonwealth of Pennsylvania laws and regulations and local building code requirements.

The period of performance will commence upon the receipt of the Notice to Proceed and should be completed within 45 days thereafter. HACP is amenable to adjustments in the delivery schedule due to unforeseen weather conditions.
