Item 1: Q: I am looking for a point of contact with the Housing Authority or City of Pittsburgh that can let me know why, under section 283111.01 Digital Addressable Fire Alarm System they only list one manufacturer.

To receive competitive bid, I would think you would want to see more than one manufacturer. We work with Notifier, Potter, to name a few that are equal and above the specs of a SimplexGrinnell system.

Is this a decision that is made by the Housing Authority or is this decision coming from Gerard Associates Architects, LLC, who is listed for this project

A: Products listed in the construction documents specifications are subject to the “as approved equal” specification listed in the construction documents. Equivalent manufacturers are acceptable as long as they are compatible with existing fire alarm wiring and devices.

Item 2: The bid due date, time and location remain unchanged at March 29, 2022 at 10:00 AM, at the HACP Procurement Dept., 100 Ross St. 2nd Floor, Suite 200, Pittsburgh, PA 15219.
