ADDENDUM NO. #1

This addendum issued May 9, 2022 becomes in its entirety a part of the Invitation for Bid IFB #2022-38 4 Prime Contractors for Manchester Redevelopment as is fully set forth herein:

- **Item 1: Q:** Will the contractors awarded the contract for the Manchester Redevelopment project be managing the Final Cleaning once the project is complete, or will HACP manage the process?
 - A: Final cleaning of each unit will be the responsibility of the General Contractor and should this scope of work should be included in the aggregate bid amount.
- Item 2: Q: Is an electrical permit required for each unit?
 - A: Yes, an electrical permit is required for each unit, however, permits are being applied for separately by Allies & Ross Management and Development Corporation.
- **Item 3: Q:** Is an electrical inspection required for each unit?
 - A: Yes, an electrical inspection is required for each unit. Allies & Ross Management and Development Corporation will independently engage a Third Party Inspection Agency and pay the requisite fees, however, the Electrical Contractor will be responsible for coordinating all electrical inspections for all of the units in the project.
- **Item 4: Q:** Will the bases of design for the Door Bells, Thermostats, Bathroom Ceiling Mounted Exhaust Fan, and Kitchen Diffused/Register/Grille be provided?
 - A: Yes, door bells, thermostats, bathroom ceiling mounted exhaust fans, are provided in the specifications and FF&E Pricing Sheet. The kitchen diffused / register / grille are provided in the architectural plans in the mechanical schedules.
- **Item 5:** Q: Can you confirm we are not required to install arc fault breakers in the units?

- A: Arc breakers will be required.
- **Item 6: Q:** Per the manufacturer, the Type A light Fixture is being discontinued. Please provide an alternate.
 - A: The alternate Type A light fixture is: Nuvo Lighting Single Light 7-1/2" Wide Outdoor Flush Mount Bowl ceiling Fixture with Frosted Glass Shade. \$17.99 Model: SF77/921
- Item 7: The Allies & Ross Management and Development Corporation will only be accepting physical proposals dropped off in person from 8:00 AM until the closing time of 10:00 AM on June 7, 2022 in the lobby of 100 Ross St. Pittsburgh, PA 15219.
