July 28, 2022 VIA ZOOM WEBINAR

WHEREAS, the total collection losses written off from the Tenant Accounts Receivables (TARs) balance is \$58,194.60 which is 2.76% of the total rent and associated charges of \$2,110,954.29 for the 2nd quarter of 2022.

WHEREAS, Marshall Electric and Tri-River Holdings LLC were determined to be the most responsive and responsible bidders.

Section 1 The Executive Director or Designee is hereby authorized to enter into a contract in the amount not to exceed \$500,000.00 with Marshall Electric and Tri-River Holdings LLC for Electrical Support Authority-Wide for the initial term of three (3) years with two (2) one (1) year extension options, for a total of five (5) years; and

Section 2 The total five (5) year authorized amount of \$500,000 shall be split amongst the two (2) winning vendors and made payable from program income and/or Moving to Work (MTW) funds.

WHEREAS, the Housing Authority of the City of Pittsburgh (HACP) utilizes Refrigeration, Heating, Ventilation, and Air Conditioning (RHVAC) Support Services across all HACP locations; and

WHEREAS, on May 31, 2022, the HACP issued an Invitation for Bid (IFB) #300-03-22 seeking qualified companies to provide RHVAC Support Authority-Wide; and

WHEREAS, the IFB #300-03-22 was procured in accordance with applicable federal, state, and local procurement rules and regulations, as well as the procurement policies and procedures of the HACP; and

WHEREAS, two (2) companies responded to the IFB #300-03-22 for RHVAC Support: Tobey-Karg Service Agency, Inc., and Tri-Rivers Property Maintenance; and

WHEREAS, Tobey-Karg Service Agency, Inc. and Tri-Rivers Property Maintenance were both determined to be responsive and responsible bidders.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Pittsburgh:

Section 1 The Executive Director or Designee is hereby authorized to enter into a contract in the amount not to exceed \$201,746.00 with Tobey-Karg Service Agency, Inc., and Tri-Rivers Property Maintenance for RHVAC Support Authority-Wide for the initial term of three (3) years with two (2) one (1) year extension options, for a total of five (5) years; and

Section 2 The total five (5) year authorized amount of \$201,746.00 shall be split amongst the two (2) winning vendors (each being awarded \$100,873.00) and made payable from program income and/or Moving to Work (MTW) funds.

A Resolution – To Set Aside 25 Housing Choice Vouchers for the 811 Program for Persons with Mental Health Disabilities

WHEREAS, the Housing Authority of the City of Pittsburgh (HACP) partnered with various entities to create housing opportunities for a diverse group of families, to include and not limited to families with diverse special needs, to include physical and mental health needs; and

WHEREAS, on or about May 8, 2017 the HACP entered into a Memorandum of Understanding (MOU) with the Pennsylvania Housing Finance Agency (PHFA) to set aside 25 vouchers awarded by the Department of Housing And Urban Development (HUD), under the Section 811 Project Rental Program to assist persons with mental health disabilities who are ages 18-61; and

WHEREAS, the HACP agreed to allocate 25 vouchers with a preference for adults with serious mental disabilities and, as a targeted population of persons who are 18-61 years of age; and

WHEREAS, the HACP pursuant to the MOU agreed to use the Allegheny Department of Human Services as the referral source for the 25 vouchers for the stated population.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Pittsburgh:

Section 1. The Executive Director or his Designee is hereby authorized to set aside 25 vouchers awarded by HUD under the Section 811 Project Rental Program to assist persons with mental health disabilities who are ages 18-61; and

Section II. The expense of the 25 vouchers will be paid for with program income and/or Moving to Work (MTW) funds.

A Resolution - Authorizing the Executive Director or his Designee to Enter Into An Emergency Contract with Reliant IT to Provide a Security Camera System for the Mazza Pavilion Hi-Rise.

WHEREAS, a fire occurred at the Mazza Pavilion Hi-Rise on June 10, 2022, causing sprinkler systems throughout the building to be activated; and

WHEREAS, the water from the activated sprinkler systems destroyed the installed security cameras and caused them to be damaged and inoperable; and

WHEREAS, the Housing Authority of the City of Pittsburgh (HACP) has a continuing need for security cameras at the Mazza Hi-Rise as a part of its plan to synthesize resources from law

enforcement, private security, and technology to enhance the safety and security of the HACP communities; and

WHEREAS, when the residents return to their units, as they were relocated based on the conditions after the referenced fire, the HACP will need to have security cameras in place for the security of the residents; and

WHEREAS, on March 24, 2022, Reliant IT was authorized through Board Resolution 16 of 222, to install security cameras at the Allegheny Dwellings and Bedford Dwellings family communities; and

WHEREAS, Reliant IT has performed the work at the referenced sites to the satisfaction of the HACP to include meeting the timeline deadlines; and

WHEREAS, as time is of the essence to restore the security system cameras at the Mazza Pavilion Hi-Rise when the residents return to their units, the HACP selected Reliant IT to provide the services and equipment; and

WHEREAS, the term of the emergency contract is for one (1) year with the option to extend four (4) one-year contracts; and

WHEREAS, this procurement was conducted in accordance with applicable State and Federal regulations and the procurement policies and procedures of the HACP.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Pittsburgh:

Section 1. The Executive Director or his Designee is hereby authorized to enter into an emergency contract with Reliant IT, to install security cameras at the Mazza Pavilion Hi-Rise, for a one (1) year term with an option to extend four (4) one-year contracts, for a five (5) year combined total not to exceed \$70,000.00; and

Section 2. The contract shall be payable from program income and/or Moving to Work (MTW) funds.
