#### ADDENDUM NO. 5

This addendum issued January 18, 2024 becomes in its entirety a part of the IFB #2023-40 as is fully set forth herein:

- **Item 1: Q:** Has the budget of the project changed since the last time it was bid, or does the budget not matter?
  - **A:** The budgetary range amounts were listed in the various newspapers that advertised IFB #2023-40.
- **Item 2: Q:** The wage rate determination schedule issued with the bid documents is dated 2/25/2022. Is this rate schedule still current for the project?
  - **A:** Yes, however should a more recent wage determination become available it will be included in a subsequent addendum to IFB #2023-40.
- **Item 3: Q:** Are specification divisions 27 Communications & 28 Electronic, Safety & Security to be included in the General Trades or Electrical scope of work?

- **Item 4: Q:** Electric Vehicle charging pedestals are shown on the site civil plans with reference to refer to the MEP drawings for additional details. Please identify which prime contract is to include them.
  - A: Electric Vehicle charging pedestals are the responsibility of the EC.

**Item 8: Q:** Can we have clarification on which windows are to receive Horizontal Louver Blinds? Is it all windows throughout the project or just the windows located within the units?

**A:** All windows shall be provided with Horizontal Louver Blinds and blocking for a Curtain Rod. This does not include Storefront Windows in the "Commercial Space 150".
