ADDENDUM NO. 1

This addendum issued March 14, 2024 becomes in its entirety a part of the IFB #250-06-24 as is fully set forth herein:

- Item 1:** Q: What is the anticipated start date for the awarded contract?
 A: **With April board approval, a May 2024 start date will be determined**
- Item 2:** Q: Was there a prior contract for this work?
 A: **Yes**
- Item 3:** Q: Are grass seeds and straw to be billed separately?
 A: **If required, yes**
- Item 4:** Q: What is the service expectation for 0 Devilliers Street (0011-A-00290-0000-00)?
 A: **Minimal and regular cutting/trimming with a mower or weedwhacker to ensure lot remains in compliance with PLI and Allegheny County Health Department code. Removal of any discarded trash.**

Item 5: Q: Is the use of a weedwacker acceptable? As the terrain does not appear to be appropriate for the use of mowers.

A: **If using a weedwacker fulfills the scope of services length wise, yes**

Item 6: Q: Will the barrier be removed to allow full access to the lot?

A: **No**


Item 7: Q: Is the expectation to have a lower bid for the two extension years?

A: **The expectation is the vendor will bid on a three-year contract**


