ADDENDUM NO. 2

This addendum issued August 28, 2024, becomes in its entirety a part of the IFB #300-25-24 as is fully set forth herein:

Item 1: Q: Can you provide the manufacturer and year installed for the missing information for the following elevators?

- 330 46th Street
- Brighton Place
- Christopher Smith and the address of this elevator location

A: These locations are in transition to our portfolio, so we do not have this information.

Item 2: Q: On the bid form, how were the "estimated annual hours" for each of the rates for one mechanic and teams determined? (400, 250, 50 and 140, 80, 40)

A: They were estimated figures based on historical work performed and forecasting figures looking ahead at the aging infrastructure of the systems.

Item 3 Q: Will the labor rates on the bid be required to be used for billable repair work during the contract?

A: Yes.

Item 4: Q: Can you provide the annual average billable repair work per year for each of the last five years of the previous elevator maintenance contract?

A: No. For more information, you must file a Right to Know Request. The Right to Know Request contact and form can be found on the HACP website: <u>www.HACP.org</u> the "About" tab under Open Records Officer.

Item 5: Q: Can you confirm that the "maintenance cost/month" on the bid form is supposed to be the estimated amount for parts and materials only?

A: It is for the monthly PM services.

Item 6:Q:Will necessary repair or cleaning work be billable during the initial month of the
new maintenance contract if the work was required due to pre-existing conditions?A:No.

Item 7: The bid due date, time, and location remain unchanged at September 17, 2024, at 9:00 a.m., at the HACP Procurement Dept., 412 Boulevard of the Allies 6th Floor, Pittsburgh, PA 15219.

Item 8: The Housing Authority of the City of Pittsburgh will **only be accepting physical bids dropped off in person from 8:00 AM until the closing time of 9:00 a.m. on September 17, 2024, in** the lobby of the One Stop Shop at 412 Boulevard of the Allies, Pittsburgh, PA 15219. All proposals must be received at the above address <u>no later than September 17, 2024, at 9:00 a.m. regardless of the selected delivery</u> <u>mechanism</u>.
