- Item 7:** Q: Do you want moisture board installed behind the tub surrounds?  
A: **Yes**
- Item 8:** Q: Will change orders be allowed after the bid is accepted if something out of scope occurs that is required to complete the tub surrounds?

- Item 9:** Q: One is on the tub surrounds the contractor supply the tub surround and on the safety grab Do we supply them?
