Quote Request – Tub Surround Installation

ADDENDUM NO. 3

This addendum issued January 24, 2025, becomes in its entirety a part of the Quote Request as is fully set forth herein:

Item 1: Q: If we tear down a surround and there is mold found how should we proceed and we will be compensated to treat the mold if that is your decision

A: **An HACP technician will treat the area.**

Item 2: Q: Because there is no walk through for these units, to properly bid, we need either pictures of current conditions or specs of the bathroom areas that needs replaced, can HACP provide.

A: **Height of surround 58” – 3 piece fiberglass; back wall 56” wide / side wall 30”; open floor space 5x5.**

Item 3: Q: Can you please advise what materials will be provided for this project so that I know what the expectation is?

A: **Tub surround, adhesive, blueboard, drywall, mud, window kit, fixtures, primer, paint.**

Item 4: Q: Are there specific manufacturers that HACP approves of?

A: **N/A - HACP will supply the tub surrounds**

Item 5: Q: What size are the 7 areas that need surround shower?

A: **See Item 2**

Item 6: Q: What material is preferred for the 7 surround showers, acrylic, fiberglass, tile, stone etc.?

A: **HACP will provide the fiberglass tub surrounds.**

Item 7: Q: Can we assume that all showers will be installed in the City of Pittsburgh?

A: **Yes**

Item 8: Q: Are all showers going to be installed at the same property?

A: **Yes**

Item 9: Q: Is the area residential or commercial?
A: **Residential**

Item 10: Q: Please advise if the contractor will also be responsible for hardware such as faucets, knobs, shower heads, etc. or are these also materials that HACP will provide?
A: **HACP will provide fixtures – See Item 3.**

Item 11: The due date is changed to January 30, 2025; time and location remain unchanged at 10:00 a.m. Bids should be emailed to loreal.cryder@hacp.org.
