ADDENDUM NO. 1

This addendum issued June 13, 2025, becomes in its entirety a part of the Invitation for Bid IFB #250-16-25 REBID as is fully set forth herein:

Item 1: Q: Are early submissions considered final?

A: Yes, however you can withdraw your bid and submit another bid to us as long as it's within the time frame. Just be aware that we will need written notice to terminate your previously submitted bid for the new submission to be accepted.

As per IFB Part 2. II.13.5: "Bids may be withdrawn by written notice, prior to award. A bid may be withdrawn in person by a bidder or its authorized representative if, before the award, the identity of the person requesting withdrawal is established and the person signs a receipt for the bid"

Item 2: Q: Does the Dropbox location require a paid subscription to Dropbox?

A: No, Dropbox submissions are facilitated through the Dropbox File Request system and do not require any formal Dropbox account or subscription

Item 3: Q: What is the Independent Cost Estimate for cleaning a single dryer duct?

A: The Independent Cost Estimate serves as the primary in-house gauge of cost and price reasonableness. To ensure the integrity of the procurement system and to ensure that contracts are awarded fairly, based on merit, without improper influence, these cannot be disclosed and are categorized as confidential information.

Item 4: Q: Please describe the accessibility of the dryer vents at each location (i.e. outside vents < 20ft high).

A: It is the responsibility of the Contractor to determine how they will access the Vents.

Item 5: Site visits are scheduled for June 23, 2025, and June 24, 2025. The times and locations are below. The walkthroughs will begin promptly at the allotted times. Vendors coming late or visiting outside these times will not be accommodated. All vendors must have a valid ID and appear at the main office of each location.
