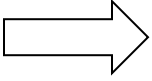

- 1) The provider will respond to requests for this service within any Housing Authority of the City of Pittsburgh (HACP) communities within the city of Pittsburgh. See Attachment A for property listing.
- 2) This work will include all materials and equipment needed to complete such requests.
- 3) The provider will respond to each site as requested within 48 hours to assess the tub cut installation.
- 4) The provider will begin and complete the work within ten (10) days of the assessment.
- 5) The provider will start and complete the work on the same day.
- 6) The provider will be contacted by the Facility Services Senior Project Manager and/or the Site Manager to coordinate all work performed between the contractor and the resident.
- 7) The provider will bid a per-unit price for the complete job, which will be used for all tub cuts throughout the contract.
- 8) Work area to be left in a clean and safe condition.
- 9) No debris to be placed in HACP trash receptacles.
- 10) The vendor is responsible for obtaining all required permits.
