## Abatement of Hazardous Materials RFP #600-34-25 ADDENDUM NO. 1

This addendum, issued October 21, 2025, becomes in its entirety a part of the Request for Proposals RFP #600-34-25 as is fully set forth herein:

Item 1: Offerors are encouraged to limit their submission to the Work Category Area(s) where they have a proven track record. It is not necessary for firms to submit a proposal addressing all Specialty Areas and they may submit a proposal for a single Specialty Area. If firms are responding to more than one Work Category Area, they should submit a separate section in their proposal for each area. More than one firm may be selected for any individual Work Category Area.

**Item 2:** Q: After reviewing the RFP a few questions arose. We specialize in strictly Radon Testing and Abatement, and we had noticed a handful of other hazardous material services needed. Will this RFP be looking to find a singular company to provide all services or can we place a bid to cover only the radon services? If so, is there any simplified form?

A: The terms and conditions of the RFP are hereby changed. Attachment A Rate Sheet is hereby removed and replaced with a rate sheet per work category as listed below and attached hetero. Offerors may submit proposals on any or all work categories. Each work category will be evaluated pursuant to the evaluation criteria in Section V of the RFP. All other terms and conditions of the RFP remain unchanged.
