The Housing Authority of the City of Pittsburgh (HACP) held a Special Meeting of the Board of Commissioners on Thursday, October 2, 2025, via Zoom Webinar at 9:00 a.m.

The HACP Board Chair, Wasi Mohamed, called the meeting to order. The Commissioners in attendance: Ms. Jala Rucker, Ms. Charlise Smith, Mr. Wasi Mohamad. Ms. Janet Evans, Mr. Khari Mosley, Mrs. Valerie McDonald-Roberts and Ms. Tammy Thompson. A Quorum was met.

Oakland Planning and Development Corporation is the managing partner for Quippa LP, a 49-unit LIHTC project in West Oakland. Many of our tenants are housing choice voucher holders, and our PHFA-approved budget absolutely depends on the rent subsidies these vouchers provide. Our 2025 and 2026 budgets are now under water because we have experienced significant challenges working with HACP's online system, and have received no timely response from HACP staff.

Our organization has worked productively with HACP for many years, managing vouchers for tenants at all our properties. This summer was the first time HACP required use of their online portal to submit lease renewals – but Quippa LP was never provided access to the portal. We were denied rent increases for 17 units at Quippa LP because we were not given access we were required to have until after the relevant window for increase requests had closed.

Our property management team has made regular requests for portal access for Quippa LP over multiple years. Despite our pleas for help and the supporting files we had sent on time via email, mail, and fax making clear we did not have the required online access, HACP staff denied our request to increase rents for the remainder of 2025 and the entirety of 2026.

We all know how much costs are increasing, and how much policy decisions in Washington are negatively impacting these essential programs. However, this problem is local, and is entirely of HACP's own making. Please do not compound everyone's struggles by failing to take adequate responsibility for administrative failures. Our tenants deserve better.

### **RESOLUTIONS:**

Resolution No. 88 is being presented to the HACP Board of Commissioners (BOC) today as it was previously presented to the BOC on September 25, 2025 (Resolution No. 76) and did not pass in the affirmative. The Commissioners requested more time to review the document. The Homeownership Plan is an attachment to the FY 2026 MTW Annual Plan and as a required document it is due to HUD on October 15 which is prior to the HACP's next regular scheduled Board meeting on October 23, 2025. ### **RESOLUTION No. 88 of 2025**

# A Resolution - Approving the FY 2026 HACP MTW Homeownership Program

WHEREAS, the Housing Authority of the City of Pittsburgh (HACP) is a participant in the federal Moving to Work (MTW) Demonstration Program. The HACP MTW Homeownership Program is a U.S. Department of Housing and Urban Development (HUD) approved MTW activity and is contained in the MTW Annual Plan appendices.

WHEREAS, the current HACP MTW Homeownership Program Plan (Policies and Procedures) must be amended to clarify policy and procedures and to maintain compliance with federal regulations as they pertain to the HACP as a participant in the MTW Demonstration Program; and

WHEREAS, the proposed amendments to the HACP MTW Homeownership Program Plan (Policies and Procedures) will clarify and replace existing provisions under the current HACP MTW Homeownership Program Plan (Policies and Procedures); and

WHEREAS, the proposed amendments to the HACP MTW Homeownership Program Plan (Policies and Procedures) include clarifying application and waiting list policies, adjusting closing cost and soft second mortgage funding, implementing a home warranty requirement and education component, clarifying the foreclosure prevention fund, and adding sections on partnership, outreach, education, non-discrimination, program oversight, administration, and recordkeeping; and

**WHEREAS**, the proposed amendments to the HACP MTW Homeownership Program Plan (Policies and Procedures) were posted in the local newspapers from Sunday, August 16, 2025, to Tuesday, September 16, 2025; and

**Section 1.** The Housing Authority of the City of Pittsburgh (HACP) MTW Homeownership Program Plan (Policies and Procedures) requires approval by the Board of Commissioners and once approved, the Executive Director or his Designee is authorized to submit the amended Homeownership Program Plan (Policies and Procedures) to HUD.
