ADDENDUM NO. 1

This addendum issued March 23, 2026, becomes in its entirety a part of the Invitation for Bid IFB #300-14-26 as is fully set forth herein:

Item 1: Q: Will we be provided the counts for how many emergency lights per building?
A: **See Attachment B**

Item 2: Q: Will we be provided the counts for the types of fire panel per building?
A: **See Attachment A**

Item 3: Q: Will we be provided how many detectors per building for the sensitivity testing?
A: **See Attachment A**

Item 4: Q: For items 1, 2, and 3 above, will there be time for surveys of the buildings if we aren't provided the counts per building?
A: If a visit is needed, arrangements will be made available

Item 5: Q: The scope of work listed, read it's like an annual inspection of all initiating devices, with sensitivity testing. Can you please confirm.
A: **This is for annual testing of all initiating devices and 100% sensitivity testing of smoke detectors for the First Year. Then 50% sensitivity testing smoke detectors for the 2nd Year. 50% sensitivity testing smoke detectors 3rd Year. Then 4th Year is 100% sensitivity testing of smoke detectors. And the 5th Year is 50% sensitivity smoke detector testing.**

Item 6: Q: Will a bond be needed for this IFB?
A: **No**

Item 7: Q: Can we use Sourcewell to price this out?
A: **Bids will be awarded on the basis of the contractor who submits the lowest responsible bid that is most advantageous to this Authority. All bidders are required to submit their firm-fixed price for providing the goods or services requested under this IFB in accordance with Attachment 1, titled "BID SHEET."**

Item 8: The due date, time, and location remain unchanged at April 8, 2026, at 11:00 a.m., at the HACP Procurement Dept., 412 Boulevard of the Allies 6th Floor, Pittsburgh, PA 15219.

Item 9: The Housing Authority of the City of Pittsburgh will **only accept physical proposals dropped off in person from 8:00 AM until the closing time of 11:00 a.m. April 8, 2026**, in the lobby of the One Stop Shop at 412 Boulevard of the Allies, Pittsburgh, PA 15219.
