ADDENDUM NO. 1

This addendum issued June 29, 2026, becomes in its entirety a part of the Invitation for Bid IFB #300-24-26 as is fully set forth herein:

Item 1: Q: Section II.15 References - The second paragraph seems to be intended for a construction project. Please confirm if bidders are required to submit the last three jobs they performed and all change orders related to that job.

A: Yes, bidders need to list three (3) firms, governmental units, or persons for whom the bidder has previously performed work of the nature requested under this IFB.

Item 2: Q: Section II. 17 Assurances of Completion - Please confirm no bid bond or performance bonds are required for this contract.

A: There is no bonding requirement for this solicitation.

Item 3: Q: Section II. 21 Term of Contract - Are the options years at the sole discretion of the HACP or of mutual consideration of both parties?

A: This remains at HACP's discretion.

Item 4: Q: Section 7. Termination - Will the Authority consider removing the termination for convenience clause?

A: No.

Item 5: Q: Section 7. Termination - Will the Authority consider allowing a cure period of 7 days for any material breach?

A: If HACP issues a Notice to Cure, the specific timeline will be stated within that notice.

Item 6: Q: What is the start date for this contract?

A: This has not yet been determined.

Item 7: Q: What is the anticipated award date for this contract?

A: This has not yet been determined.

Item 8: Q: Will the Authority provide a full month of scale tickets (or a summary of all scale tickets) for each site to all bidders?

A: **Scale tickets vary from 3 ton – 5 ton each**

Item 9: Q: What are the addresses for the North View and St. Clair Dump?

A: **Northview is at 533 Mt. Pleasant Rd and St. Clair is at 1070 Fisher St**

Item 10: The due date, time, and location remain unchanged at July 9, 2026, at 10:00 a.m., at the HACCP Procurement Dept., 412 Boulevard of the Allies 6th Floor, Pittsburgh, PA 15219.

Item 11: The Housing Authority of the City of Pittsburgh will **only accept physical proposals dropped off in person from 8:00 AM until the closing time of 10:00 a.m. on July 9, 2026**, in the lobby of the One Stop Shop at 412 Boulevard of the Allies, Pittsburgh, PA 15219.
