ADDENDUM NO. 2

This addendum issued September 14, 2026, becomes in its entirety a part of the Invitation for Bid IFB #600-22-26 as is fully set forth herein:

Item 1: Q: Could you please confirm the vendor registration requirements and advise whether there are any specific bonding, insurance, prevailing-wage, Section 3, MBE/WBE, or other qualification requirements applicable to the General Construction contract?

A: **There are no vendor registration requirements to submit a bid or proposal. All bid submission requirements are listed in the IFB documentation available at www.hacp.org.**

Item 2: Q: Please let me know if there is a bidder list available or a way to be included in future HACP commercial renovation and general construction opportunities.

A: **Bid documents are available at www.hacp.org, vendors must register directly on the website to be included in email communications for current solicitations. This includes IFB #600-22-26 which is being managed under HACP's legacy procurement system.**

Effective November 2, 2026, HACP will be transitioning to a new procurement system. To continue doing business with the HACP and submit bids or proposals, ALL vendors must create an account on our new procurement portal. Those without an account in the new system will not be able to view or submit to our solicitations.

This is a required, but simple step. Here's how to create your account:

- **Visit the Vendor Portal:**

- **Select "Register" at the top right corner**
- **Enter your primary contact details and email address.**
- **Confirm your email address to complete registration.**

Item 3: The due date, time, and location remain unchanged at October 1, 2026, at 10:00 a.m., at the HACP Procurement Dept., 412 Boulevard of the Allies 6th Floor, Pittsburgh, PA 15219.

Item 4: The Housing Authority of the City of Pittsburgh will **only accept physical bids dropped off in person from 8:00 AM until the closing time of 10:00 a.m. on October 1, 2026**, in the lobby of the One Stop Shop at 412 Boulevard of the Allies, Pittsburgh, PA 15219.
